INTRODCUTION

The Ministry of Primary Industries and Social Empowerment was established by the Gazette Extraordinary dated 16.01.2019 bearing number 2106/9 of the Democratic Socialist Republic of Sri Lanka subsequent to the Cabinet reshuffle made in January 2019, as the successor to the Ministry of Labor, Trade Union Relations and Social Empowerment established by the Gazette Extraordinary dated 28.12.2018 bearing number 2103/33 of the Democratic Socialist Republic of Sri Lanka. Accordingly, the programmes of this Ministry are executed under the three sectors of Social Empowerment, Social Welfare and Primary Industries.

This Ministry carries out its functions aiming at empowerment, welfare and protection of the rights of the poor and marginalized people in Sri Lanka and the promotion of the field of Primary Industries by providing efficient, beneficial and benevolent social and economic services.

The Departments/Institutes and Units under the purview of the Ministry provide an immense contribution towards the attainment of its vision of "Poverty-free, Rights protected Sri Lanka by 2030" by implementing a number of programmes and projects.

Social Empowerment Unit leads its activities towards socially and economically empowerment of low income earning groups, production of Social Work Professionals, empowerment of people with a view of sustainable rural development and provision of social protection for those who are indulged in various occupations which are not eligible for a government pension.

The Department of Samurdhi Development is engaged in carrying out the massive development programme that fuels the enforcement of the national policy on ensuring social justice and eliminating poverty with a view to upgrade the economic development programme of low income earning communities.

Samurdhi Development Division implements projects to promote infrastructure facilities in backward villages where Samurdhi beneficiaries reside and co-ordinates with the Ministry of Land and Parliamentary Affairs in land acquisition matters by the Department of Samurdhi Development.

Human Resource Development and Special Projects Division organizes a variety of training programmes to enhance the knowledge, attitudes and skills of the officers of the Ministry and affiliated institutions focusing on utilizing their services productively to achieve the mandate of the Ministry.

The National Institute of Social Development is the prime institution fulfilling the country's requirement of Social Welfare Professionals by providing education based on the arena of social work.

The Rural Development and Research Institute accomplished with a vast experience in actively contributing for a sustainable rural development and community empowerment is in the process of delivering its relevant functions.

Sri Lanka Social Security Board delivers pensions and social security benefits to all employees who are not entitled to a government pension such as self employed persons, elders, disadvantaged persons, single parents, foreign employees, artists etc.

Thus Social Empowerment Division actively contributes to the socio-economic scenario of the poor community in the society.

The subject of Social Welfare was affiliated in 2018 to the Ministry of Primary Industries established in 2015 which implements programmes with a view to double the annual export income by the year 2025 aiming to raise the annual export income up to US\$25bn. through soaring the value-chains related to the export production sectors of Agro, Fisheries and Livestock that constitute the backbone of the economy.

The Primary Industries Division in involved in formulation and implementation of policies, plans, programmes and projects required to ensure a better tomorrow and a sustainable livelihood for all stakeholders in the sector, augmentation of productivity in primary industries including Agro, Fisheries and Livestock productions regulating all the industrialists and entrepreneurs in primary industries sector and increasing our foreign exchange reserves through introducing the value-added products to the world market.

The Department of Export Agriculture pays a special attention to the exportation of the crops of cinnamon, black pepper, cardamom, coffee, cocoa, arecanut (Areca catechu), citrus, vanilla, lemon grass (Cymbopogon), betel (Piper betel), goraka (Garcinia Cambogia), kithul (Caryota urens), Ginger and turmeric (Bauhinia tomentosa). The main responsibility of it could be stipulated as the introduction of technical knowhow, new products and varieties of species yielding a high harvest while continuing providing extension services and indulging in

research development affairs in the export crop sector. The main goals of the Department could be stated as cultivation of export agriculture crops, processing, manufacture of valueadded products and securing and strengthening the living standards of about two million of stakeholders who make a living acting as middlemen in the trade.

The Agricultural Sector Innovation Project is implemented with the aim of provision of a grant based on the investment to the entrepreneurs and agro product organizations with innovative ideas. The project is implemented under the three components of value chain development in agriculture sector, productivity promotion along with diversification and commercialization.

The Social Welfare Division has implemented welfare programmes for elders or senior citizens amounting to 2.5mn of the total population in Sri Lanka, 1.7mn of disabled persons, children with special needs, stress and depression inflicted persons and drug addicts such as social welfare, security, maintenance and welfare programmes required for sustainable living, rehabilitation programmes and economic activities to ensure and promote living standards.

Accordingly, the Department of Social Services executes its functions geared by the social development goals including promotion of vocational skills of disabled persons and making them independent citizens, rehabilitation of drug addicts and early intervention in the development of the children with special needs.

The National Secretariat for Persons with Disabilities is vested with the responsibility of creating an affable environment for disadvantaged persons of the society through promotion of the rights of the persons with disabilities and provision of relief including welfare.

The National Secretariat for Elders contributes to provide protection to the elders while motivating them through various programmes focusing on endorsement of their self esteem, participation, self fulfillment, security and freedom.

Counseling Division is engaged in maintaining counseling services and programmes including around the clock mobile phone services with the intension of the provision of standard counseling services to safeguard children and other persons who have succumbed victims of stress and depression in this existing socio-economic environment and the world of technology.

This report comprises the progress of the development programmes executed by the Divisions of Social Empowerment, Primary Industries and Social Welfare in the year of 2018.

01.1 Administration Division

1.1.1 Introduction

Managing administrative, establishment, transport and information technology activities of the Ministry, and managing and coordinating the administration and establishment activities of the departments and institutions under the Ministry

1.1.2 Objectives

- i. Managing the establishment and administrative activities related to the staff of the Ministry and all institutions under the Ministry
- ii. Development of human resource through providing local and foreign training
- iii. Contributing to policy formulation by properly submitting Cabinet Memoranda and Bills etc. pertaining to the subject scope of the Ministry.
- iv. Providing human resource and infrastructure facilities required for carrying out the operations of the Ministry.
- v. Facilitating coordination between all institutions of the Ministry.

1.1.3 Strategies

- i. Identification of staff requirements of the Ministry and maintaining up to date information of such details
- ii. Identification of office equipment, communication equipment and infrastructure requirements and making necessary arrangements accordingly.
- iii. Conducting training programmes to enhance motivation of the staff
- iv. Through proper delivery of mail received by and sent from the Ministry, contributing to efficiency of the respective divisions.
- v. Proper maintenance and repair of vehicles and deployment of vehicles according to requirements
- vi. Proper positioning of staff

1.1.4 Achievements from 2018.01.01 - 2018.12.31

- i. Making 125 officers of the Ministry and Institutions under the Ministry participation in 36 foreign training courses
- ii. Submitting 26 Cabinet Memoranda
- iii. Performing establishment activities of 12 newly appointed Public Management Assistants and attaching them to the Divisions as per requirements
- iv. Having conducted the interviews in the formal manner for the vacancies existed in the Office Assistant Service of the approved cadre of the Ministry, 4 officers were recruited to the Ministry

- v. Performing establishment activities of 19 officers who got transfers out and 16 officers who got transfers to this Ministry
- vi. Performing the establishment activities of 2 officers who got transfer upon the reaching of 60 years old
- vii. As per the Extra Ordinary Gazette Notification No. 2070/56 dated 12.05.2018, the counseling Division, National Secretariat for Elders and National Secretariat for Persons with Disabilities were vested in the Ministry of Social Welfare and Primary Industries and inter Statutory Board on protection of Kandyan Heritage was vested in the Ministry of Ministry of Science Technology, Research, Vocational Development and Kandyan Heritage.
- viii. Accordingly, establishment affairs of 291 personal files belonging to officers in the Ministry of Primary Industries and Social Welfare were completed and handed over. Establishment affairs of 08 personal files belonging to the officers of the Ministry of Science, Technology, Research, Skills Development & Vocational Training and Kandyan Heritage were completed and handed over.
- ix. A Tamil language course of 50 hours was conducted for the primary category officers in the Ministry to fulfill the requirement of such officers for the second language and 23 drivers /office assistants participated in the course
- x. Providing tariffs relief for 1 Institution with regard to the social service subject
- xi. Providing salary increments to the staff of the Ministry on due date

1.1.5 Expected socio economic benefits

Fulfilling the needs of ministry staff and institutions through managing human resource and financial activities in an efficient manner

1.1.6 Challenges faced

- i. This Ministry was named as Ministry of Social Empowerment in terms of the Gazette Extra Ordinary No. 2070/56 dated 12.05.2018 accordingly the Ministry had to approve the required staff within a short period of time with regard to the subjects and functions of all Divisions and therefore physical resources were duly managed.
- ii. As per the Extra Gazette notification no 2096/68 dated 09.11.2018 issued subsequently, personal files of 287 officers in the Ministry of Social Services and Primary Industries and institutions under its purview were rejoined and establishment activities of such files were also assigned.

1.1.7 Achievements - 2018

- i. Proper management of the available limited resources to meet the requirements
- ii. Punctually carrying out the establishment activities related to the staff
- iii. Maintaining a sound coordination between the staff members of the Ministry

1.2 Accounts Division

1.2.1 Introduction

Obtaining of annual provisions for operations and development programmes for the Ministry of Social Empowerment, financial management and making payments are the functions of the Accounts Division and it is the authorized division exercising the authority vested on the Chief Accounting Officer by the Financial Regulations to keep state accounts and maintain a transparent financial discipline.

Accounting processes of this division are carried out under the guidance, management and direction of the Chief Accountant and supervision of the accounts of the statutory institutions and boards in addition to the accounts related to the Ministry, are-also carried out by this Division. For this purpose, together with the Chief Accountant, a budget assistant, two supply assistants, three development officers and ten management assistants are engaged in active service.

1.2.2 Main Objectives

According to the provisions of the Financial regulations, special directives and government circulars applicable to the social development programme and vision of the Ministry of Social Empowerment, Welfare and Kandyan Heritage, for the year 2018 :

- i. Preparation of the annual aggregate budget of the Ministry and submitting the same to the Department of National Budget.
- ii. Keeping correct and up to date accounts on all transactions and submitting of such accounts
- iii. Formulation of financial policies and strengthening of financial management.
- iv. Monitoring all receipts and expenditures and controlling expenditures
- v. Making suitable proposals to the higher management to review expenditure
- vi. Submission of final accounts to the treasury and the Auditor General's Department and coordination in that regard
- vii. Assisting to implement financial regulations properly through a transparent procurement procedure in all purchases
- viii. Providing the financial assistance recipients throughout the island with their allowances by the due date and time.
- ix. Maintaining the government assets under the Ministry, collecting revenue and supervision
- x. Assisting with proper maintaining of the financial and accounting procedures of the Ministry and the establishments under the Ministry

1.2.3 Strategies

Accurately operating the accounting systems introduced by the government adhering to the given timeframes, and utilizing the productivity of such systems for enhancing the efficiency of the Division

- ii. Carrying out reconciliations of accounts registers to avoid exceeding the allocation limits.
- iii. Making correct management decisions related to obtaining of supplementary allocations for high expenditure votes, and raising the awareness of the relevant institutions to make such decisions
- iv. Properly studying the government policies and financial regulations, and taking necessary actions expeditiously to direct such policies and regulations to the relevant divisions/institutions
- v. Taking necessary steps to avert clash between related roles through proper distribution duties, and abiding by the instructions of the higher management.
- vi. With a comprehensive monitoring on all subjects, consulting the higher supervising officers to make management decisions for expediting the delayed work units and implementing such decisions
- vii. For implementation of island wide programmes, adopting a network mechanism in collaboration with district secretariats and divisional secretariats
- viii. Paying special attention regularly to the instructions of the Secretary and Additional Secretaries on the development projects and monitoring activities, and accordingly, communicating with relevant subject directors and taking measures in a transparent manner to ensure financial discipline
 - **ix.** Carrying out a monthly expenditure analysis by maintaining monthly expenditure reports on all votes and accordingly referring the projects with slow progress to the higher management for improving their progress.
 - x. If the provisions, which are allocated annually, are not spent as per due dates /quarters, taking actions to transfer such provisions to other essential Objects in terms of the Provisions as stipulated in the Financial Regulation 66/69
 - xi. Having provided the training for the officers in the Accounts Division to improve their efficiency, engage them in service following the promotion of their performance.

1.2.4 Achievements -2018

- i. The recurrent allocations made through the 2017 budget against the votes under the Ministry's Head 124 had indicated a progress of 97% in utilization. This year, it has been managed to have 93.50% of utilization by 31 December 2018
- ii. As against 2017, in the current year, it has been managed to keep in a position parallel to 2018 in the approved capital allocations under head No.124. This allocation indicates a utilization of Rs.333.39 million as at 31 December 2018.
- iii. The Division managed to submit all required accounts reports, the 2017 Appropriation Account, Annual Report of the Public Officers Advance B Account and answers to all audit quarries to the Auditor General's Department before the due date.
- iv. The imprest required for development and operations expenditure was obtained as follows from the Department of Treasury Operations as at 31 December 2018.

1.2.7. Challenges faced

- i. Changes taking place in the expected allocation requirements against the respective votes because of preparation of the estimates for the year to come 10 months in advance and subsequently changes occurring in the estimated values during the particular period.
- ii. In provision of monthly allowances to beneficiaries, since the allocations are released to Divisional Secretariats on the islanded basis, it causes difficulty to identify suitable alternatives promptly for the inefficiencies in the process due to the delay in carrying out monitoring to ascertain whether provision of allowance has been done on the due date itself and delay in obtaining of progress details
- iii. Due to changes of the subjects of the Ministry again in 2018, it is difficult reach the targets in the development projects who are being implemented at present

iv. In expending the allocations received for 2018 for construction activities, difficulty in reaching the expected targets due to delays caused by late submission of relevant payment vouchers by construction agencies and adverse weather conditions.

1.2.8 Achievements - 2018

- i. Ministry of Social Empowerment has obtained the fourth place in the evaluation survey conducted by the Committee on Public Accounts on the usage, maintenance and updating the public accounts in 2018
- ii. It was able to obtain the instructions and supervision of the Hon. Minister and Deputy Minister in preparing the budget estimates of 2019
- iii. It was able to submit the budget estimate of 2019 on due date following its preparation related to the Ministry of Social Empowerment
- iv. It was able to submit the many new projects for 2019 in comparison with 2018 and to receive the approval to the same
- v. Successfully conducting the annual board of survey and disposing of the worn-out equipment following the proper procedure and crediting the income to the government income.
- vi. Maintaining the financial management in a better manner in the current year in which it was possible to minimize the number of audit queries in relation to 2017.
- vii. It was able to submit the following accounts reports which to be submitted in 2018. on due date
 - a. Appropriation Account 2017
 - b. Advance Account 2017
 - c. Final Account under accrual basis 2017
- viii. It was able to fulfill the financial targets to achieve the sustainable development goals.

1.3 Internal Audit Division

1.3.1 Introduction

Internal Audit Division of the Ministry of Social Empowerment, Welfare and Kandyan Heritage, according to F.R.133, functions under a Chief Internal Auditor directly responsible to the secretary to the Ministry.

1.3.2 Objectives

Guiding the Ministry on achieving the expected development goals through conducting of financial audit, performance audit, management audit, environmental audit, system control audit and vulnerable sectors based audit, required for carrying out the services and programmes of the Ministry in a quality and efficient manner. Under this;

2.1 Introduction

Rural Development Training & Research Institute, established in 1974, is the pioneering institute which applies participatory development methodologies for the National development programs. Rural Development Training and Research Institute launched an Action research in order to experiment the Participatory Development Approach for the first time in Sri Lanka. We have contributed to a number of development programs such as Janasaviya, Samurdhi, and Gama Neguma through introducing social mobilization methodologies in order to enhance the people participation for those programs. Currently Rural Development Training and Research Institute is comprised from main 4 divisions, namely Training, Research, Publication and Planning.

2.2 Vision

"To be the pioneer institute to empower the community for a prosperous Sri Lanka"

2.3 Mission

It can be seen historically that the communities who are marginalized from the main development stream have not been able to receive the anticipated benefits of development. Rural Development Training & Research Institute acts as the strategic which bridges these communities with the main development stream.

2.4 Objectives

- i. Develop the participatory development methodology as a basic methodology of rural development
- ii. Monitoring the field offices to direct combination with families and community in the empowerment process.
- iii. Build up coordination with provincial councils to enhance the provincial rural development programs.
- iv. Publish annual, semiannual and term publications to share the information relating with rural development.
- v. Conduct open forums about current social issues to empower the community
- vi. Publish annual development publications for policy makers, development workers and rural development leaders.

The major activity of this Samurdhi Development Department which was established under the DiviNeguma Act No 01 of 2013, revised by the Samurdhi Act no. 02 of 2017, is empowerment of poor people in Sri Lanka to eradicate poverty of the country by providing welfare facilities to 1.4 million of poor families in Sri Lanka through providing allowances to protect them in their special events by Social Security Fund, implementing livelihood development programmes and providing Micro Loan facilities to those poor families and other low income families through 1074 of Community Banks spread island widely. In addition, Establishment and maintain community based organization network gathering poor families and low income people in the country and implementation of various social development programmes are the other activities of this Department.

" To be the pioneering institute of the country to create poverty free, empowered and prosperous Sri Lanka in year 2030"

3.3 Mission

"To empower marginalized people (economically, socially, politically, spiritually, legally and environmentally) and contribute to national economy for development of poverty free prosperous country through implementation efficiency, effective and faster response in a community friendly manner to minimize regional disparity, in corporation with other Departments, community organizations, micro-financial agency network, professionals, government and private sector, community and political sector and national and global Institutions"



National Institute of Social Development operates under the purview of the Ministry of Primary Industries and Social Empowerment is the only government education institute provides Social Work Education in Sri Lanka. National Institute of Social Development was established as a higher education institute under the Act no.41 of 1992 and declared as a degree awarding institution under Section 25 A of the Universities Act No.16 of 1978 in 2005.



Job occupation of the Social Work Graduates pass-out of the Institute at the moment. 73.53% are occupied in jobs. 14.71% out of total students (female) are unemployed due to personal reasons. Marriage, Child birth and higher education can be show as special reasons. Even though 11.76% were previously engaged in jobs now they are unemployed due to the reasons such as searching for other jobs, going abroad for higher education.

44.83% students are working in non-governmental organizations and International non-governmental organizations and that has been useful in promoting Social Work Profession and increasing the demand. 24.14% are serving for government and private organizations.

According to student sample all students are serving in executive level jobs as well as project coordinator, project manager, research assistant, computer programmer, custom officers, Police officers and Bank officers. Many students are in the early stages of their jobs.

5.1 Introduction

Sri Lanka Social Security Board, which has been established in accordance with the Social Security Board Act No. 17 of 1996 and Sri Lanka Social Security Board (Amendment) Act No.33 of 1999, is a government statutory board, executed under the Ministry of Social Empowerment.

Sri Lanka Social Security Board provides the social security to all, who need the coverage of the government pension during their older age and benefits like monthly pension to the spouse in case of death of the subscriber, partial disablement benefits and total disablement benefits before reaching the pension entitlement, death gratuity are implementing in-an-assured-manner. While implementing the government's economic policies in practical manner, the role of the Sri Lanka Social Security Board is to provide pension and social security benefits to those who are not entitled to a government pension.

5.2 Vision

A proud nation secured with social security

5.3 Mission

Towards a sustainable development while incorporating strategic alliance with government and non-governmental organizations in place of the economic social and cultural security of the Sri Lankan citizens aligned to good governance practices through formulating, executing and regulating social security policies for building a proud nation.

5.4 Objectives

- 1. To provide social security to self-employed persons during their old age and on disability
- 2. To provide relief to the dependents of self-employed persons, in case of their death
- 3. To encourage self-employed persons to continue in their respective occupations and to develop their capabilities and skills
- 4. To encourage youth to be self-employed and to develop their capabilities and skills
- 5. To educate self-employed persons on the benefits of thrift and resource management
- 6. To improve the living standards of self-employed persons generally.

5.5 Strategies

- 1 Implementing the pension and social security benefits schemes to provide pension to those who are not entitled to a government pension.
 - Implementing the "Surekuma" scheme to provide the high and a safeguarded monthly pension payment to all those who are in the ages of 18 to 59 years, and are not entitled to a government pension.

- "Arassawa" preplanned Social Security Benefit scheme was introduced to the children, who are below the age of 18 years under the guardianship of their parents or guardians.
- 2. Benefits of the Pension and Social Security Pension Schemes
 - > To provide a pension at the age of 60 years until the demise of the contributory members.
 - At the demise of the contributory member before reaching to the age of 80 years, payment of the pension to the spouse.
 - If a contributory member becomes permanent and partially disabled he is entitled to a disability gratuity up to Rs. 25,000/-.
 - If a contributory member becomes permanently incapacitated he is entitled to a lump sum allowance of Rs. 50,000/- and/ or the monthly pension from the date on which the member is incapacitated
 - To provide a death gratuity of Rs. 25000/- to the dependent at the demise of the contributory member before reaching to the age of 80 years
- 3. Granting financial benefits to the children at the passing of national examinations under "Arassawa" Social Security Benefit scheme.
 - To provide a financial benefit of 50% from the agreed monthly pension at the passing of Grade Five Scholarship examination, having obtained the required cut off marks in the same
 - To provide a financial benefit equal to the agreed monthly pension at the passing of G. C.E. (Ordinary Level) with 05 distinction passes
 - To provide a financial benefit equal to double amount of agreed monthly pension at the obtaining of qualifications to enter the local national university, having passed the G. C.E. (Advance Level) examination properly
- 4. Implementing a combined pension and social security benefit programme with government sector, private sector and voluntary organizations.

5.6 Output - 2018

- i. Enrolling 62933* members to the pension and social security benefits schemes
- ii. Paying pensions to 28742 elders
- iii. Paying permanently disabled allowance to 27 members
- iv. Paying death gratuity to 61 members
- v. Providing financial benefits to 445 school children



Primary Industries and Social Welfare Section



6.1 Role of the Primary Industries and Social Welfare Section

6.1.1. Primary Industries Division

- I. Supplying facilities to all stake holders to produce the value added finished goods and for export and supplying facilities to combined such goods to the global market while developing the value chain of the products of primary industries including the agricultural and fishery products.
- II. Introducing the required standards for certifying the quality and high productivity of the export oriented crops and primary industry products including export agricultural crops and supply of facilities and incentives to perform the required certification to assure national and international recognition.
- III. Organizing and connecting with the local and foreign market promotion programmes, seminars, exhibitions and fairs for providing opportunities to Sri Lankan businessman in order to obtain knowledge and experiences for achieving the competitiveness in the global market.
- IV. Supplying necessary lands to medium and small scale entrepreneurs to start their business through the establishment of agricultural and fishery high zones and providing other necessary assistances for this purpose.
- V. Providing physical and economic infrastructure facilities and incentives to new entrepreneurs including new technological equipment, post-harvest technology and agro loans with in high zones and outside the as well, in order to modernize the export agriculture Sector.
- VI. Encouraging the business by providing the financial grants, loan facilities and technical instructions required for the development of the business of investors, entrepreneurs and exporters who stand for the value added products through the modernization of agricultural section which pursues exports.
- VII. Encouraging the investments, by establishing a Trade Facilitation Unit to provide required information regarding supporting services for market with all together and investments for local and international entrepreneurs who stand for the investments.
- VIII. Providing the necessary facilities for the expansion and promotion of high value export crops including the fruit culture targeting the export and vegetable cultivation targeting the local and foreign market in particular.
- IX. While providing the necessary guidelines and to formulate annual action plan and estimates of the Department of Export Agriculture, Department of Social services, Counseling Division, and National Secretariat for Persons with Disabilities, National Secretariat for Elders and Agricultural Sector Modernization Project which are under the purview of the Ministry and assisting for the implementation, supervision and monitoring.
- X. Managing the human resources and physical resources and coordinating the administrative and establishment activities of the affiliated departments and institutions and providing the necessary guidance in order to achieve the objectives of the Ministry.

6.1.2. Social welfare Division

- I. Taking actions for providing the contented future for the senior citizens by way of formulating the necessary policies and programmes to secure the welfare and future security of the older persons who are around 2.5 million from the total population of the country (a policy for the senior citizens has been prepared and approval of the Cabinet of Ministers was received for this purpose)
- II. Introducing the necessary programmes for assuring the contribution of the government and private sector for maintaining more friendly care centers and elders homes for the care of senior citizens who are deprived of the care.
- III. Creating a suitable environment for obtaining the service of the senior citizens, who are capable of living furthermore by their self- esteem rather than being the dependents, in a productive manner while providing the required cooperation to them.
- IV. Organizing various programmes including the commemoration of the International Day for the Older Persons under the direct contribution and participation of the older persons to provide due acceptance and dignity of the society, while giving special attention to senior citizens
- V. Preparing a national policy required for assuring the rights of the disabled persons who are around 1.6 million of the total population and giving necessary guidance to all institutions in the government sector and relevant institutions in the private sector to adhere to the said policy and preparing a suitable mechanism for monitoring such institutions.
- VI. Empowering the disabled persons and persons with special needs and preparing & implementing the suitable self-employment job opportunities and livelihood development programmes for uplifting their economy.
- VII. Preparing and implementing the required programmes for improving the sports, aesthetic and other abilities of the persons with disabilities and going forward through these abilities.
- VIII. Drawing the special attention of the society towards the disabled persons through organization and implementation of the various programmes including international white can day celebration on behalf of the persons with visual disabilities.
- IX. Conducting the counseling programmes and services for rescuing the children and persons who became the intolerance and stress conditions due to various social issues

6.2. Programme and Projects Implemented from 01.01.2018 – 31.12.2018 (Primary Industries Division)

Programme – 1 Island wide Programme of Cultivating 100 Million Export Agricultural Crops Plants

One of the main responsibility which has been assigned to this Ministry is to make the basic foundation for achieving the national target of doubling the export revenue of the country alias increasing the said revenue up to USD 25 Mn by 2025. Within a very short period we should reach to this target and we should obtain a rapid growth in the export agriculture industry. Therefore, not only to take steps for encouraging the value added products while strengthening the value chains of the agricultural productions but also to make arrangements to improve the production capacity. As a step for improving the production capacity with the objective of preparing the production source necessary for the agricultural export process of the country, our ministry has already initiated a national progarmme of planting 100 Million export agricultural crops, which have production possibility and economic value, targeting exports in whole island and under this 07 Million export agricultural crops including pepper and cinnamon in the year 2016 and 13 Million crops in the year 2017 were planted. This year target is to cultivate 25 Million crops and out of this target 15 Million plants have been cultivated. In subsequence, 45 Million plants will be cultivated by the end of this year and by cultivating another 55 Million plants in the next year the above target of cultivating the 100 Million plants will be achieved by the Ministry and in connection with these, the contribution of reaching to the national target of doubling the export revue by 2025 will be provided by this Ministry.



Programme – 2 Programme to Establish 5000 Export Villages

The objective of this programme is to develop the village as export oriented village where all villagers carry out such export oriented products, having developed a value chain targeting a special export product or group of crops, which have special export potential for the selected area while targeting the export directly avoiding the middlemen in order to prevent the value addition leading to a low cost of production. In subsequence, it is expected by this Ministry to combined such products or crops with the international value chains, forward rural production directly to the international market, increase the income received from the agricultural sector by 50% and to established 5000 export villages for improving the economy of the rural producers and quality of products and the cabinet approval for this purpose has already been received.

Under this programme, which was commenced in 2018, the Ministry has already identified 250 villages and the work of developing them as export villages has been initiated on the basis of their qualitative specialty. Accordingly, introducing one village as one unit, economic security of such village will be assured and it is expected to present a structural concept while making the social and professional security thereby

Programme 3 - Establishment of High Agricultural Zones

At the time of establishing this Ministry in 2015, one priority task, which was assigned to this Ministry, is implementing the programme of the establishment of high agricultural zones with the objective of the value addition and preparation of the value chain targeting the crops scattered in divisional level and providing them with the opportunity of entering the international market directly from their own places itself. Preliminary activities of three zones under this have already been completed. Galle - Elpitiya High zone, Ampara - Uhana High zone and Matale - Wilgamuwa high zone are include to these zones and in connected with these it is expected to provide necessary financial facilities and infrastructure facilities for encouraging the investors with agricultural basis and to confirm the security of the investors and development of the human resources in divisional level and generate job opportunities and to assist for making divisional development with strategic plans. For this purpose, physical background necessary for promoting the agricultural production base (crop cultivation) as to cover whole district relevant to each zone, will be created and under this facilities are provided to promote and expand the crop cultivation suited to agricultural environmental situation in the district. In addition to this, lands and other physical facilities, necessary for the business community to commence the factories in the processing zones, having established such processing zones for processing the above products for the exports, following the targeting of a definite place identified in the district, are provided.

In subsequence, around Rs. 400 Million of government invests and minimum Rs. 1,500 Million of combined investments of government and private sectors are expected to be invested and annual Rs 10,000 Million of annual revenue is expected from each zone and accordingly Rs. 30 Billion of revenue is expected from this process of total export zones.

• Elpitiya, Galle High Agricultural Zone

In subsequence, preliminary activities of the high agricultural zone has almost completed following the identification of 72 Acres in Elpitiya, Galle belonging to the Land Reform Commission and under this activities like preliminary surveying activities, preparing of creative plans, preparing of environmental impact reports, construction of security fence, preparing the land according to the zones and etc. are being completed at present.



• Ampara high agricultural zone

The environmental impact study is being continued for the high agricultural zone of 258 Acres in extent and which has been planned to established in Uhana, of Ampara district. The physical infrastructure facilities necessary for the construction of elephant fence and security fence, construction of public road and buildings are scheduled be developed. All activities have already prepared for the commencement of productions in this high zone in the next year.

• Matale high agricultural zone

Preparation of public roads, construction of safety fence, preparation of public buildings and development of infrastructure facilities of the high agricultural zones due to be established at Wilgamuwa area in Matale district have planned to be developed. Environment impact study report has already prepared for this purpose and it is expected to establish production factories by end of year 2019.

Programme 4 - Programme to Establish High Fishery Zones

The progamme of establishing high fishery zones could be introduced as another special step in the journey of doubling our export income by 2025. This programme is aim to improve the value chains of the fishery products and to earn high amount of foreign exchange by supplying very valuable and competitive fishery products to the global market, having added the value to such fishery products. In subsequence, actions were taken to develop oyster cultivation in Puttalam and Kalpitiya lagoon areas, having established the cultivation shelves, in which preliminary affairs have been initiated and to established 200 sea cucumber gardens in the area from Pallikuda to Palavi. Plans are afoot for the establishment of a Hatchery for producing oysters continuously and systematically in the country and development of the Chilaw anchor centre for fishery and development of other anchor centres for fishery located in island wide and for providing fishing engine boats and net equipment

Steps were taken to provide the smoked fish processing units, which were provided to Ampara district as the first step of strengthening the registered fishery societies for developing the fishery value chains, to other registered fishery societies as well. Further arrangements were taken to establish water based fish hatcheries in fresh water reservoirs island wide enriched with modern technology for obtaining the continuous and systematic fresh water fish production and to introduce pearl-oysters to fresh water reservoirs with the objective of establishing and publicizing the pearl-oysters cultivation island wide and to introduce one Million fresh water fishes to the Moragakanda reservoir and other 15 sub reservoirs for promoting the fishery value chains and to introduce more 3 Million fresh water fish in future. It is expected to provide one million baby prawns for uplifting the

giant prawns production and to provide the fishing boats, fishing nets and other equipment and office facilities to the registered fishery societies. Through these development activities in the fishery field it is targeted to earn USD 250 Million of foreign exchange annually to the country.



Programme 5 - Grama Shakthi People's Movement

Under Grama Shakthi People's Movement, which is on the concept of His Excellency the President, many progarmmes and projects coming under the subject scope of this ministry have been commence since this year. It has been planned to implement numerous programmes and projects under the Grama Shakthi People's Movement in island wide by utilizing the provisions of the Ministry while identifying the potential Grama Niladhari divisions in Divisional Secretarial level by considering the physical and human resources. Providing the decision making power and resources to the community, providing equal representation opportunities, preventing the dependency mentality and creating a place in the village to obtain development through government, private and community participation are included in the policy process of the Grama Shakthi Peiple's Movement and it is expected to create about 5000 self employment opportunities through the programmes and projects implemented in rural level under this Ministry.

Programme 6 - EJC Mangoes Cultivation Project

This is one main progarmme, which has been implemented since 2016, in the Ministry. It is expected to distribute 3 Million mango plants with the objective of generating Rs. 250,000 annually to the farmer and 26,000 mango plants in the year 2016 and 280,000 mango plants in the year 2017 were distributed among farmers as cluster farmers. Among the mango plants of 550,000, which have been targeted to be distributed in this year, 321,000 mango plants were distributed and it is expected to earn USD 300 Million annually by this project.



Programme 7 - Sour Sap Cultivation Project

On the basis of the great demand for the sour sap to maintain a healthy lifestyle, this project is implemented with the objectives of promoting this crop as an export oriented crop and improving production income of a family unit. Under this, arrangements are in progress of distributing 100,000 plants among 5000 beneficiaries.



Programme 8 - Export Oriented Pineapple Value Chain Project

On the basis of the special taste in the pineapple in Sri Lanka, suitability of Sri Lankan climate for growing pineapple and specialty of this agricultural crop as a short term income generating crop, in comparison with the other countries in the world, this project is implemented in Gampaha, Kurunegala and Puttalam districts with the objective of preparing the productive background required for obtaining the competitive approach in both local and international market and improving the foreign exchange which to be received to the country. Under this project, which was initiated in 2016, it is expected to start a pineapple cultivation in 25,000 Acres in island wide and to grow 750 plant nurseries to obtain plants for this purpose by 2020 and it is targeted to obtain USD 150Million annually by this project. Further, it is expected prepare one billion of pineapple plant tissue culture for obtaining the fruitful production and 100,000 plants tissue culture have so far been distributed.





Programme 9 - Cashew Cultivation Project

This project is implemented with the expectation of promoting cashew as an export oriented product to increase the export revenue by 25% by 2020, uplifting the income of the people in Ampara district by establishing cashew high zone in Ampara district and supplying more value added products to the international market by way of increasing the eashew production. Moreover this project is implemented as a strategy for preparing a production potential required for high agricultural zone, which is being constructed in

Ampara area. Accordingly, under the first stage of the project, the plans are afoot for providing 5,000 plants to 161 beneficiary farmers in Ampara area under the agriculture sector renovation project for cultivating in Maha season and 25,000 plants are provided to selected beneficiaries in Mahaoya and Padiyathalawa areas, where there is a potential for the cashew cultivation and 11,000 plants have already been distributed. In addition to this, training progarmmes and awareness programmes are conducted for the beneficiaries under this project.



Programme 10 - Bee- keeping Project

This project is implemented with the objectives of identifying new export market source by minimizing the import of bee honey in Sri Lanka, branding Sri Lankan honey in international market as our bee – keepings are practiced in a special zone where there is high bio diversity in Sri Lanka, promoting value added products by utilizing modern strategic and technical skills in local and international markets and protecting bee honey producers and their market as a solution for scarcity of bee honey necessary for various honey based products and developing the bee keeping industry. Providing the required training for the bee honey producers in the next year, providing 3000 beehive boxes to the produces (7000 boxes have already been distributed), providing special training to find honey bee colonies, expanding the 75 cluster villages, which have been established, furthermore, providing incentives to the produces by having paid special attention to the value added products of bee honey, establishing bee producers societies and selling bee honey under one market brand in island wide, are the plans to be implemented in the next year. Further, the approval of the Cabinet of Ministers was received to establish a bee research and training center in Ampara district to strengthen this project more.



Programme 11- Mushroom Farming Project

Mushrooms, which are famous as vegetarian food with high protein and free from cholesterol, are having a high potential for exporting to Eastern and South East Asian countries. Accordingly this project is implemented with the objectives of producing mushrooms targeting the production market in the manner of achieving the local demand and improving the guilty of mushroom production. Among the future plans of the projects, providing assistances to the mushroom producers in addition to 700 producers, who were benefitted already, introducing modern technologies to substitute primary techniques which are currently practiced by the producers for assuring the product quality, minimizing the post-harvest losses and mushroom grow bag losses, providing mushroom grow bag preparation machines to the beneficiaries by this project, providing mushroom grow bag preparation machines to the beneficiaries, encouraging large scale cultivators and seed producers and distributing the mushroom production under one market brand by having provided the standard certificates following the connection of the small scale producers with large scale producers are the plans for the next year.



Programme 12 - Development of 1000 Export Agricultural Plant Nurseries

The quality of many agricultural crops at present depends on the quality of their culture materials. Accordingly, in order to assure the supply of high quality plants and culture materials continuously over the year by minimizing the impacts and damages to the plants and culture materials due to natural, climatic and other effects, plans are afoot to develop 1000 plant nurseries under the budget proposal 2018. Under the improvement of infrastructure facilities and implementation of assistive programmes through the supply of quality technology for this purpose, development activities of this project have been commence in the manner of growing the plant nurseries in the safety nets, providing the required net for this purpose to the domestic plant nursery owners, introducing compressed coir buckets as a new media for plant buckets required for the production of plants in these nurseries, introducing modern water management systems, introducing mother plant gardening methods and grading the nurseries as the criteria of A, B and C under a biannual evaluation method for improving the condition of the nurseries.

Programme 13- Export Agricultural Crop Processing Machines Renovation Programme

The main aim of this progamme is to produce safe food products free of external impurities including iron, because the main issue we faced in the global market of European countries, in particular is to assure a high demand for our products is the complaint of having external impurities including iron in our agricultural products. When it was confirmed through researches that the main course for having such impurities in the products are due to use of machines made up of iron in the processing of agricultural products, we took actions to introduce machines made up of stainless steel and to provide financial assistance and incentives to producers engaged in export agricultural crop production and processing to renovate their machines by having those iron parts of their machines replaced with stainless steel parts. For this purpose, in order to provide financial assistance and technical cooperation to the food processors the activities like registration of processors, discussion with the machinery producers on necessary steps to be taken for renovating the existing machines, preparation of legal regulations required to prohibit the use of iron parts in making new machines and etc are being performed by the Ministry at present and accordingly it has been planned to totally remove the machines made up of iron parts from the export agricultural crop processing industry by 2020.

Programme 14- Cinnamon Development Programme

Sri Lankan cinnamon is popularly known as "Ceylon Cinnamon" which is cultivated on the Sri Lankan soil and has a high demand in international market. We enjoy an unparalleled position among countries supplying cinnamon to the world market. If we are to save that unique position for the future as well, our cinnamon should be of superior standard. Cinnamon is now come to the market in powered form and as cinnamon tea, but it should be enjoyed an alternative use and an increased demand driven by health advice of various forms. The Ministry of Primary Industries has taken steps to issue a standard certificate for our cinnamon industry as we have had to complete with many cinnamon products which cannot even compare to "Ceylon Cinnamon". The research projects have been commenced with five selected Universities to conduct researches on cinnamon-based products in collaboration with the National Science Foundation. In addition to this, necessary actions have already been taken to develop the Kosgoda Cinnamon Training school for finding solutions for the lack of cinnamon crushers and which remains as a big barrier for the development of the cinnamon industry and to make professional recognition for the cinnamon processors, having commenced the National Vocational Qualification (NVO) Training courses to attract youth to the processing industry including the crushing of cinnamon. As the first step of granting this certificate, arrangements were made to grant a Recognition of prior learning (RPL) certificate to the cinnamon processors and under this 782 were granted this RPL certificate. Accordingly, it has been planned to grant the NVQ certificates to 10,000 men in the cinnamon industry.



Programme 15 - Uva Province Development Affairs

Under this programme, in order to awake the agricultural and animal husbandry fields, Bindunuwewa Service Training Institute Development Project and the Boralanda Animal Farm Development Project were implemented. In subsequence, many development activities are being conducted under this project, which is implemented with the objective of developing the Bindunuwewa Service Training Institute enabling to obtain theoretical and practical knowledge on the modern agricultural technology for all stake holders engaged in the agricultural field in Uva Province and other closed districts and producing primary seeds and culture materials necessary for seed potatoes producers in the area. Therefore, construction of protective homes for model agricultural crop cultivations, preparation of wells, ponds, Pumping stations and pipe borne water systems, construction of cold storages for storing seed potatoes, renovation of tissue culture laboratories and etc are conducted under the cooperation of the Provincial Ministry of agriculture in the Uva Province.



In addition to this, The Boralanda Animal Farm Development Project is implemented in collaboration with the Uva Provincial Ministry of Agriculture under the Uva Province for providing the milking cows on concessionary prices to the dairy farmers in Uva province following the breeding of high quality milking cows and accordingly high quality and imported 100 milking cows were provided in the year 2017. The many activities such as cattle shed equipped with modern facilities required for cattle, 16 Acre grass cultivation for the cattle, construction of silage pits, construction of a small lake for obtaining the water, preparation of pipe born water systems and others have already been completed. In the future, construction of the milk collection centres, expansion of grass cultivation furthermore, construction and etc, have been planned to be implemented. In connection with these, improvement of the efficiency of the institution through increasing these facilities, providing milk cows on concessionary prices to the dairy farmers in the area following the breeding of high quality cows thereof and accordingly contribution of improving the milk production in the country are expected by the ministry.



Programme 16 - Establishment of 10 Vegetables and Fruit Processing Centers

Identifying the demand for tropical vegetables and fruits in the international market and food cities in this country, ten centres are scheduled to be established throughout the island to carry out processing, grading storing and packaging vegetables and fruits in accordance with the standards and specifications of the international market. The first such centre has been commenced at Nachchaduwa in Anuradhapura and 95% of construction activities of this centre has already completed. Other centres are expected to set up in Badulla, Ampara, Jaffna, Puttalam, Nuwraeliya, Rathnapura and Monaragala Districts. Finding solutions for the issue of price fluctuation which is confronted by vegetables and fruit framers continuously and assuring the stable market in local and international level through providing the high standard products are the expected role in this centres and accordingly main objectives of such centers are to provide opportunity for farmers and producers to earn high income by this means.

Programme 17 - Establishment of Farm Sheds (Agro Service Centers)

With the objective of providing a remedy for the scarcity of labour in the agricultural field, attracting the young strength, who leaves the agricultural industry, to the industry again and improving the productivity in the agricultural sector through bringing the modern technology to the village, this project is implemented targeting to originate one entrepreneur of providing agricultural services to one village and 375 such units have been planned to be commenced. It is expected to make 200 such farm sheds in the next year. One entrepreneur will be provided with a tool kit including one branch cutting machine , Earth Digging Machine, oil spraying machine and land preparation machine and by utilizing these tool kits it is expected uplift the efficiency and productivity of the agricultural field through supply of necessary services to start new cultivations and to maintain the existing cultivations of the farmers.

Programme 18 - Implementation of income Generating Programmes

The responsibility of implementing the various income generating programmes for uplifting the living standard of the low income persons scattered in all island leading the Eastern Province, has also been assigned to this Ministry by a special gazette notification and accordingly steps have already been taken to implement identified small and large scale income generating programmes in various places of the country. Under this, as a step for improving the income level of the people who engage in the Batik industry in some selected Divisional Secretariats in Ampara district, actions were taken to provide a formal training to 600 beneficiaries on the Batik industry and to provide basic materials to continue their industry. Further, there was a training on cloth weaving machinery and cloth weaving for 644 beneficiaries and they were provided with the necessary equipment and other materials for starting a self employment and under the same programme, 17 women, who find it difficult to obtain the primary capital for the self employment in Addalaichenai were provided with sewing machines.

Further, with the objective of encouraging the products associated with clay and pottery industry and coir products industry, provisions have continuously been provided to coir products producers and these projected, which are mainly implemented in Eastern Province, are expected to be implemented to other provinces as well.

Programme 19- Programmes for Dissemination and Exchange of experience

General Public are continuously made aware by conducting programmes for dissemination of information and experience sharing by training in local and overseas and by participating in Trade fares and seminars and conducting expanded awareness programme on the role of Ministry on electronic and printed media.

Programme 01 - Programmes for the Persons with Disabilities

Under this, more attention was given to implement programmes for assuring the welfare and economic security of the persons with disabilities. Accordingly, necessary programmes are implemented to introduce quality products to the market under the brand name "Diriya" for improving the vocational training opportunities through vocational training institutes and voluntary organizations and winning the customer attraction by utilizing the modern technology for the products in order to develop the vocational activities of the persons with disabilities by utilizing the modern technological methods to meet the demand of the market.

Moreover, in order to provide the required facilities for the welfare of such communities, a special attention has been drawn to prepare the necessary mechanisms which are essential for preparing and implementing the necessary public policies for this purpose. In connection with these, a special attention has been drawn to the children with disabilities, whom have been identified in divisional secretarial level. Various programmes are implemented under this in the entertainment environment by organizing the special activities required for improving their education and special needs. Further, providing the formal guidance to these children, establishment and expansion of care centres in provincial level for the mentally disabled children, who are deprived of their guardians, developing the infrastructure facilities of such centers are also performed under this programme.

For the purpose of developing the cultural and aesthetic skills of the persons with disabilities various programmes are implemented in divisional, district and national level and Sith Ru Cultural Show takes a special place among those. It was attracted and praised by the young persons with disabilities in particular and by this means, these disabled youth have got the opportunity of of improving and staging their specific cultural and aesthetic abilities.

In subsequence, various programmes are implemented by this ministry for the welfare and minimization of poverty of the persons with disabilities. Providing a monthly allowance

of Rs. 3000/- per month, obtaining the drugs which are not available in hospitals in the heart, knee, hip bone and eve surgeries, providing a lump sum amount of Rs. 2000/- for travelling expenses to visit the clinic, providing an assistance of Rs. 25,000/- to engage in the self employments, providing an assistance to purchase school suppliers for school children, subject to the maximum of Rs. 10,000/- providing a monthly allowance of Rs. 5000/- to the chronic kidney disease patients, who are low income persons, granting scholarships to the children who lost their parents due to chronic kidney disease, providing assistive devices to the disable persons, providing financial assistances to the institutions / homes which provide care for the persons with disabilities and many other welfare programmes are implemented by the Ministry. Further, rehabilitation of drug addicted persons following their vocational training and socializing them by the preventive and rehabilitation project is a special project among the other projects. Providing self employment tool kits for the disabled youth who successfully complete the training, introducing job opportunities in private institutions and establishing vocational training centers in all provinces to enroll more disabled youths to the vocational training have also been performed by the Ministry.

Programme 02 - Programmes for Elderly People

The Ministry plays a specific role for the older persons by way of preparing the necessary policies and programmes for assuring the welfare and future security of the older persons whom are around 2.5 of the total population in the country. In subsequence, we perform the tremendous services to the elders, such as minimizing the isolation of elders by way of establishing the elders committees in Grama Niladhari Divisional level, setting up the day centres for elders, taking actions to prepare all elders homes according to a standard, taking appropriate actions to prevent the elders from the dependent mentality by way of making livelihood means, improving their awareness through the conduct of training and awareness programmes, identifying the needs of elders and prepare and implement policies in this regards, updating the information regarding elders, taking appropriate actions through the Maintenance Board to fulfill the justice to the parents whom have been neglected by their children and providing a monthly allowance to the low income elders.

Among the programmes planned to be implemented in 2019, standardizing and registering 256 elders homes, providing provisions for new constructions and renovations of the present elders homes as per the requests received in this regard, implementing the programmes on the basis of uplifting the health status of the elders in elders homes conduct another medical clinics in addition to the completed 12,000 medical clinics, providing 2000 eye lenses and hearing aids, providing minimum facilities and sanitary materials to the elders to live in their homes itself and conduct of physical fitness training programmes for the elders and etc, have already been planned by the Ministry.

Many active programmes are being conducted for the empowerment of the persons with disabilities following the providing of direct provisions to the establishment and development of infra structure facilities (water and electricity facilities, water mattress, air

mattress, commode and accessibility facilities) of the Swa Shakthi (Self Esteem) organizations to minimize the issues in which the disabled persons may daily face. Under this, 14,000 rural level elders committees will be empowered in the next year and in line with this programme, Swa Shakthi (Self Esteem) organizations of the disabled people in the divisional secretarial level will be empowered and Swa shakthi Abhimani National Awards will be granted to the disabled for assessing the members with various talents in national level. Accordingly, Swa Shakthi Abhimani National Awards ceremony was ceremonially held in the year 2018 as well in the Lotus Pond, theatre.

Programme 03 - Counseling Services

Within the socio economic environment and technical world, the group with special counseling needs is rapidly increasing in the every layer of the society, which works with mental stress and pressure. It is a current requirement for providing a standard counseling service to these groups and for this purpose, the Ministry has conducted many programmes like preparing a legal frame work for rendering a standard counseling service, recreation of the 24 Hours Mobile Phone counseling service, developing the skills of the counseling officers, coordinating & supervising the counseling activities divisional, district and national level, conduct of group counseling programmes for preventing the communities from attacking the mental disorders, construction of Sithsrana counseling centres and etc and many other programmes are by implemented by the Ministry. In the

meanwhile, there were some other programmes conducted by the counseling division under the purview of the Ministry, among them, conduct of the counseling clinics and programmes for the people, who were affected by different disasters in the last few years, conduct of the "Subodhya" counseling programme for the public officers, conduct of pre marriage programmes in the selected divisional secretariats, conduct of personality development and leadership skill programmes and group activities for the school children and teachers, conduct of awareness programmes on " Mental health in the professional life" for the office based officers, and increasing awareness among the media personnel in district level to obtain the publicity for above mentioned programmes were highlighted.

In concurrence with the International Mental Health week, we were able to take the leadership in the preparation of a mechanism of monitoring the counseling service among the professionals in the counseling field, make a dialogue on the new trends and to empower the service gainers in mentally through the supply of individual counseling services in district and divisional level. These endeavors can be named as our achievements and further, we were able to make 318,768 beneficiaries made aware by conducting 6547 programmes on the promotion of mental wellbeing to minimize mental sicknesses. Moreover, among other socio economic benefits, which our Ministry achieved are that skill development of the officers for providing quality service for the service gainers, having increased the knowledge of the counseling officers on the new trends of the counseling field and development of the theoretical and practical knowledge on the counseling subject.

Allocation for the year 2018 due counselling Division for the above programme is Rs. 25.00 Mn and the total expenditure is Rs. 14.488 Mn by 31.12.2018.

The Cabinet approval has been obtained for the policy on primary industries, having formulated the said policy through UNFPA. In subsequence, through all these programmes, projects and activities, our ultimate faith is that we will be able to create a better tomorrow to the country secured with exports and to create a secured future for the communities with special needs and senior citizens.

7.1 Introduction

Through Sri Lanka had won a reputation for spice since ancient times a national level focus on this industry was made by the National Agriculture Policies 1971. There after, affiliated to the Ministry of Plantation Industries, Department of Minor Export crop was established through a cabinet Memorandum in 1972. This department was brought under the Department of agriculture in 1975. In place of the cultivation of spice crops on marginal lands which was the duty of the department then, the Department of Export Agriculture became the pilot of development in export based development in spice and allied crops with the vesting on the department a part of the functions of the crops Diversification Development projects initiated by the World Food Programme (WFE) and the United Nation's Development Programme (UNDP).

The department was renamed as the Department of Export Agriculture by the parliamentary Act No; 46 of 1992. Thereby, legal authority with regard to the export of spice and other agricultural products was vested on the department. Since then, this department has been directing field research as well as all the development activities.

Accordingly, by being the export in spice sector, the department facilitates the relevant stakeholders in the sector by establishing an islanded network of development and extension in the sector.

As for its main focus, the Department of Export Agriculture targets the export of the following categories of crops. cinnamon, pepper, clove , nutmeg, cardamom, ginger and turmeric as spice crops. While coffee, cocoa, vanilla as beverage crops and betel and areca nut as stimulant crops have captured the attention, of the development. While the main responsibility being the introduction of nursery technological knows – how innovation and varieties producing high yield the department continues providing, research, development and research services towards the promotion of the field of export agri crops.



(Value Chain Development Program)

Value chain development component of the ASMP Project, funded by the World Bank and implemented by the Ministry of Primary Industries and Social Empowerment aims to develop value chains in promoting commercial and exportoriented agribusiness and value addition.

Overall Project Development Objectives are to support increasing agriculture productivity, improving market access, and enhancing value addition of smallholder farmers and agribusinesses in the project areas with strategic objectives of agriculture diversification and technology improvement, value-chain development for higher value-added production and better market linkages, and income generation from agriculture. It is expected to support existing and newly established farmer producer organizations and agribusinesses. The matching grants are designed to finance sub-projects that are locally identified through an open call-for-proposals during the 5-year project implementation period.

The project design is built on the concept of Agricultural Value Chain Development based on partnerships of the public and private while supporting modernization of the sector. The approach to support entire agricultural value chains is a successful development tool to generate agriculture growth by adding value along the value chain and solving growth restricting bottlenecks of actors from the farmer to the national and/or international consumer. The project takes into account that this vertical integration cannot function in isolation and considers horizontal integration elements too in the chain aiming to promote commercial and export-oriented agribusiness and value addition.

The total cost of the project is Rs. 16 billion and out of which Rs. 9 billion will be provided by the International Development Association (IDA) and the World Bank.

At the first call of proposal opened in 2017, 1262 business concept notes were received and out of those 502 were qualified to enter into the process. Out of qualified

concepts 84 were approved by the Board of Directors for grant financing including individuals of the cluster programs of aqua culture and crop based industries. In the second call of EOI/Concept notes opened in 2018, a total of 287 EOIs were received and 140 were identified as eligible to receive grants subject to fulfilling other requirements and the approval of the Board of Directors. Due to similarities and homogenous nature of business enterprises in similar sub-sectors, 790 projects have been identified to be implemented under the clustering program, with the total estimated investment value of over Rs. 01 billion for the Shrimp and Ornamental Fish breeding entrepreneurs.

After completing all necessary pre-requisites, 81 proponents entered into grant agreements and the first tranche of the grant was released for 16 proponents while another 5 received the second tranche too by 31st December 2018.

In 2018, the month-wise release of grants to 81 proponents include: Rs 11 million in June, 4.5 million in July, 18.7 in August, 17.5 million in September, 57.2 million in October, 76.6 million in November and 161.1 million in December.

All in all, a total of Rs 244.6 million was released in 2018 and the cumulative expenditure is around Rs 697 million. Accordingly, nearly 34 % of financial progress was made during 2018 while the cumulative being 36% for the total project implementation duration from the inception.

It is envisaged that through utilizing these grants, the proponents who received the grants would be in a better position to modernize and upscale their business and contribute to increase foreign exchange earnings in the agriculture sector making overall economic growth in the country while enhancing social inclusion in agricultural value chains.

Department of Social Services

9.1 Introduction

The Department of Social Service was established on 1st of February 1948, in accordance with the recommendations made by the Sir Ivor Jennings-headed Social Service Commission appointed in 1944, and at present the Department of Social Services operates under the Ministry to which the subject of social service is assigned.

In 2018, pursuing the mission of the Department, a variety of programmes identified in line with provisions allocated for the year have been implemented in a planned manner from grassroots level to the national level. Especially, the Department of Social Services has achieved a successful progress in the programmes implemented aiming at the well-being of the community of the youth with disabilities. Thus, it has been possible to make a significant progress under the programme for livelihood development of the youth with disabilities, through provision of vocational training and integration of them with the society.

The Community Based Rehabilitation programme implemented for the benefit of the persons with disabilities has achieved a progress of 96.6% in the year 2018. This programme is implemented at divisional and district levels in a planned and methodical manner for providing services to the persons with disabilities. What makes this programme a special is that all field officers attached to the District and Divisional Secretariats carry out their duties related to this programme, in a well-coordinated, systematic and dedicated manner personally attending to the programme tasks. It deserves special mention that the programme has been an immense success in the hospital-based activities that were carried as part of the programme to benefit the persons with disabilities. I take pride in being able to mention that all field officers at the grassroots level are rendering a great deal of services that do not come to be reflected in the Performance of the Department.

Four national level programmes planned for 2018 for the betterment of the community of persons with disabilities were successfully conducted. The objective of these programmes is to create mutual cordiality, understanding and trust among the trainees, their parents, staff and other related persons. It has been possible to reach the final stage of the construction of new buildings in Killinochchi and Batticoloa which are particularly aimed at the welfare of the youth with disabilities in the North-East areas.

With a view to providing service facilities by making early intervention to minimize the physical and mental problems faced by children, the Child Guidance Center has been established in Maharagama to operate as the Colombo-based service center. A considerable progress was achieved this year in the programmes implemented through the Child Guidance Center. It was possible to complete by about 50% of the work of the Child Guidance Center being constructed in Kottawa in the Colombo district for expanding the services provided by the Child Guidance Center. Rehabilitation of drug addicts is one of the major programmes being implemented by the Department of Social Services. Residential rehabilitation and socialization of drug addicts, and conducting drug-prevention programmes at local level have achieved a considerable progress. The officers delivering such services have been directed to take part in local and foreign workshops, seminars and training courses with a view to enhancing their efficiency, motivation towards the work, and service productivity.

It should be particularly mentioned that as a whole, it was possible in 2018 to achieve a progress of 93.77% in the programmes implemented in the interest of the disadvantaged and distressed community. A provision of Rs. 552,780,000 was received from the General Treasury against the estimates submitted for recurrent allocations for 2018, out of which provision, a sum of Rs. 521,040,446 was expended to satisfy service requirements. A provision of Rs. 154,880,000 was allocated by the General Treasury for capital expenditure and a sum of Rs. 142,539,506 was expended within the year to carry out the planned tasks.

- vi. Empowering the voluntary organizations that provide services to the persons with disabilities.
- vii. Carrying out residential rehabilitation, providing vocational training, rehabilitation and socialization of 300 drug addicts.
- viii. Providing proper guidance to the persons affected by various present social issues.
- ix. Reinforcing the knowledge, skills and attitudes of the service delivering officers.
- x. Providing special Identity Cards to 500 persons with impaired hearing.
