02. National Council & National Secretariat for Persons with Disabilities

Mission

"Mission is to ensure the rights of Persons with disabilities through guidance, support, coordination, implementation and monitoring of development activities"

Objective

Implementation of laws enacted by Act No.28 of 1996 for promotion, advancement and protection of rights of persons with disabilities.

Functions and activities

His Excellency the President has appointed a National Council for Persons with disabilities in terms of the provisions of Act No 28 of 1996 for promotion, advancement, and protection of rights of persons with disabilities

Accordingly, decisions taken by this National Council on following matters are being implemented.

- Promotion of welfare of persons with disabilities.
- Prevention and control of main causes of disabilities.
- ❖ Maintenance of accurate statistics on persons with disabilities.
- ❖ Taking action to rehabilitate persons with disabilities
- Monitoring of activities of Institutions providing assistance to persons with disabilities.
- Fulfillment of needs of persons with disabilities.
- ❖ Formulation of programmes and policies, provision of guidance to prepare a proper` physical environment for persons with disabilities.
- Enhancement of making aware of the public on needs and situation of persons with disabilities

Legal Drafting

A new Bill has been drafted for ensuring rights of handicapped persons by revising the Persons with Disabilities Rights Ensuring Act No. 28 of 1996. It was referred to the Legal Draftsman Department and his observations have been received. The National Council has decided to discuss widely on the matter.

Provision of Rs. 3000/- to families with disabled persons under the "Mahinda Chintana" programme.

Under the "Mahinda Chintana" programme, Rs.598 Mn. has been allocated for this purpose, for the year 2013 and out of that, Monthly Life Assistance of Rs. 3000/-each has been provided to 16,600 poor families with disabled members. Accordingly, a total sum of Rs 598 Mn. has been utilized by the end of December 2013.

Educational assistance to children with disabilities.

A sum of Rs. 1.27 (mn) has been granted to 246 disabled children as Educational Assistance for the period from January to December 2013.

Courses on Brail Methodology, Sign Language, mobility and Orientation

- Two courses for public officers in various ministries and representatives of volunteer organizations have been conducted between the period on 18 February and October 2013.
- ii. A course for 28 officers of the Ministry of Education was conducted between the period on 05th May 2013 and completed in December 2013.
- iii. A course for 51 Social Services officers of North western province was completed in July 2013. All these three courses cover the Brail Methodology, Sign Language, Mobility and Orientation.

In addition to that, action has been taken to provide the following services.

- i. Taking action to translate question papers and answer scripts of visually handicapped students in government schools on Brail system.
- Translating reports of National Council for Persons with Disabilities on Brail System.
- iii. Providing educational facilities to visually handicapped students who sit for the Advanced Level Examination.

Assistance to Victoria House

A sum of Rs 6.0. Mn. has been allocated to the Victoria House, dedicated to incurables in Rajagiriya for the year 2013. Accordingly, action has been taken to meet monthly expenses at the Victoria House amounting to Rs. 500,000/-.

Outstanding Achievements in the year

- ❖ After recognizing sign language by the Cabinet of Ministers, the following Bills had been drafted under the direction of Hon. Felix Perera, Minister of Social Services and had been referred to Legal Draftsman Department.
- ❖ Special collective programmes have been planned to improve children affected with Autism under the guidance and directions given by HE the President and Minister of Social Services, in collaboration with Ministries of Education, Health services and Child Development & Women's Empowerment. The collaborative action plan in this regard had already been submitted to the National Planning Department for approval. Necessary training to identify these children is being given to field officers of the Western Province.
- ❖ As a result of the lengthy discussions held with the Ministry of Transport under accessibility Order No. 01 of 2006 on accessibility facilitations for the handicapped, few CTB buses facilitated for the handicapped could be deployed on main routes. As well, the Railway Department is taking action to construct all railway stations on newly constructed North and Mannar rail ways with access facilitations.

❖ National Action Plan on Disability.

This plan is being translated in to Sinhala and Tamil languages with approval of National Council and action would be taken to refer it to the Cabinet.

\$ Legal protection for White Canes.

On submission of a Cabinet Paper aimed to ensure, promote and develop rights of persons who depend on white canes to the Cabinet of Ministers on 17.10.2013, approval has been received to refer the same to the Legal Draftsman to prepare a Draft Bill.

03. Community Based Rehabilitation Programme for Disabled - C BR

Objective

Developing disabled persons to enable them to enjoy their rights and discharge their responsibilities and, creating opportunities in ongoing social development programmes in order to integrate them into society and thereby to bring about equal opportunities for them.

Background

It is the internationally recognized norm for co-habitation that the disabled persons should also the co-members of the society and entitled to equal rights as enjoyed by the others in their communities as wells as being treated on equal terms with others in satisfying their needs such as education, health, employment, accessibility facilities, welfare or any other requirement through the existing system. Ministry of Social Services implements such programmes in 331 Divisional Secretary divisions in 25 districts in the island. The Community Based Interactive National Programme can be identified as a key development programme being implemented under the Ministry of Social Services for safeguarding and ensuring the rights of the disabled for co-habitation.

The term "Community Based Rehabilitation" is interpreted as a community development process aimed at developing disabled persons to enable them to enjoy their rights and discharge their responsibilities and, bringing about equal opportunities for them and integrat them into society. In the implementation of the CBR programme, Steering Committees represented by various Ministries and Departments, Non Governmental Organizations and resource persons have been established at national, provincial, districts, divisional and rural levels. Also, "Swashakthi" organizations comprised of disabled persons and their family members should be set up at district and divisional levels to empower them.

Activities

➤ Implementing programmes for disabled persons and their family members to promote positive attitudes among them and provide them with knowledge on life skills.

- ➤ Conducting daily life skills programmes required for doing one's work independently at home, society, pre-school, university or work place etc.
- ➤ Referring disabled children to specialized education systems or in the interactive educational background and to provide access to education and for other services.
- ➤ Providing employment opportunities in unison with the Labour Ministry and private sector for empowering them economically and Pre-conditioning them for employments.
- > Taking action to provide vocational training through vocational training institutes at regional and national levels.
- ➤ Integrating disabled persons into programs of other ministries and departments such as Divi Neguma, Sports, Cultural etc.
- > Pro Active participation in various social religious Cultural programs.

Strategies to be adopted for this purpose

- Updating National Operation Committee comprised with inter Ministries and Non Governmental Organizations.
- ➤ Formulating and implementing five year plans for CBR programme according to decisions arrived at the National Operational Committee.
- Updating understanding for implementing National Policy on disability in Sri Lanka by conducting District Committee head by all District Secretaries.
- ➤ Conducting workshops on new trends of C.B.R. programme and recording / noting for all officers such as Social Services Officers, Social Development Assistants, Child Rights Promotion officers attached to all Divisional Secretariats in all districts.
- > Conducting interactive workshops for field officers at divisional level.
- ➤ Conducting workshops for rural leaders at Divisional Secretary Division level.
- Establishment and empowerment of Swashakthi organizations of disabled persons.
- Establishment of Parent Associations of the disabled and educating them.

- > Conducting training workshops for volunteer employees
- > Collection and reviewing of monthly progress reports and Field Training Workshop for Provincial Assistant Officers.
- Conducting job fairs

05. Single Parent Family Development programme

Objective

It is a common occurrence among children deprived of a school education due to poverty with the increasing tendency of single parents number in the society of present. The objective of this programme is to improve living standards of the under privileged Sri Lankan citizens who have become single parents due to the spouse and children being deserted by their partners or due to the demise of spouse, by assisting them in tackling their economic difficulties.

Selection of beneficiaries

- ➤ Women with underage children and school-going children, who have become vulnerable due to terrorist activities, communal war situation, accidents, suicides or untimely death of their husbands.
- For families where wife and children have been deserted by the husband or, husband and underage children have been deserted by the wife.
- ➤ For those women who are not legally married but have underage and school-going children and without sufficient means of income to satisfy the needs of these children.

According to statistics of the 2001 Census conducted by the Department of Statistics, there are 209,839 single parent families in 18 districts of Sri Lanka with the highest number being reported from the Kurunegala district. Among the most affected group of these single parent families are the small children and women. Protection, care and self respect of these people are severely affected due to this adverse situation with them. As a result, improvement of education and nutrition of children is hindered, which has in turn exposed them to various social abuses.

Further, according to a study done by the Ministry of Education, it has been revealed that 2% of children at the school-going age are not attending school mainly due to poverty. A considerable portion of this group is from Single parent families.

For alleviating this situation, the following activities are carried out under this programme.

- 1. Assistance to commence self employment for the development of single parent families and follow -up action
- 2. Assistance to collective self employments projects of small groups and follow up action,
- 3. Improving economic ceilings of mothers/ fathers of single parent families, educating them on social responsibility and role in family, upgrading, enhancing knowledge needed for uninterrupted education of their children by upgrading economic status, implementing programs to provide technical assistance to carry out their projects and implementing programs to strengthen family bond of the identified vulnerable families.

07. Social Care Centre Project

Mission Creating a Caring Society

Objective

To provide a comprehensive and coordinated social welfare package to the service users who come to the Social Care Centre/Unit to obtain services.

The Cabinet of Ministers at its meeting held on 14/12/2005 approved the Cabinet Paper No.05/1972/023/001 approved to establish Social Care Centres in Tsunami affected areas and also establish these centres in other Divisional Secretary Divisions if the project is successful and gathers momentum.

The common objective of establishing Social Care Centers is to provide an integrated Social Care package to the service users in a user friendly environment. This is a well thought out model for comprehensive service delivery. It helps to identify the issues of most vulnerable in the development process while providing them the necessities. Thus, Social Care Centres act as a safety net to the most vulnerable society. Programmes for upgrading the knowledge and Skills of the field officers will be conducted by the Social Care Project in order to deliver coordinated services to the society.

The programme is a joint venture implemented by Ministry of Social Services, Ministry of Child Development and Women's Affairs and Provincial Councils. The following officers are attached to the centre.

- 01. Social Services Officer (Central Govt./Provincial)
- 02. Counseling Assistants
- 03. Elders Rights Promotion Officer
- 04. Social Development Assistant
- 05. Women's Development Officer
- 06. Child Rights Promotion Officer
- 07. Early Childhood Development Officer
- 08. Relief Sister

In addition, the Divisional Secretariats get the service of Probation Officers and non Govt. officers also while delivering the services through Social Care Centres. By now other field officers also are being attached to most of the centres.

By end of year 2008, 27 centres were established in Western, Southern and Eastern Provinces under the sponsorship of UNICEF and Save the Children in Sri Lanka. In 2009 having realized the efficiency and effectiveness of service provision through social care concept the concept was introduced in other divisions by establishing a Social Care Unit but without putting up a separate centre.

At the end of 2012, 96 Social Care Centres /Units have been established and during 2013 the Social Care Units were established in Kandy (1) Badulla (03) Moneragala (2) Divisional Secretariats. From 2009 onwards this family based Social Care Concept has been implemented by officers instead of the interpersonal service deliveries, Continuous training on knowledge and skill development of officers is being done by the Ministry.

An Experience sharing /progress review programme to all field officers in 6 social care centres in Galle. This programme was headed by District secretary Galle and 50 officers participated. Expenditure incurred was Rs.49,750/-.In addition a work shop was held to prepare training modules.

20 psychosocial officers have been recruited to serve in Mannar, Vavuniya, Kilinochchi and Mullaitivu Districts during the period.02 workshops were held and expenditure incurred Rs.44,900/-. In addition 02 counselling workshops (one day workshops) were held for all officers attached to Pallai Divisional Secretariat. Total expenditure incurred was Rs.73,447/-.

Office Supplies

computers, computer tables ,chairs and printers were distributed to Badulla and Moneragala Districts' Divisional Secretariats for the use of social care units. Accordingly 5 computers, 10 computer tables & chairs and 10 printers were distributed to Badulla district DS divisions and 2 computers, 10 computer tables and chairs and 11 printers were distributed 10 Monaragala district.

Capacity Development Programme

03 skills development programmes on social care concept and usage (2day programmes) were held at Polgolla Cooperative Training Centre to train field officers of Kandy, Matale and Nuwara EliyaDistricts. 231 officers participated in the above 3 programmes and expenditure incurred was Rs.451,267/-. One programme was conducted at Polonnaruwa for the field officers of 7 Divisional Secretariats in Polonnaruwa. Total Expenditure was Rs.131,345/-. Another workshop (2 days) was conducted in Ampara for 27 Field officers of 7 Divisions(Sinhala) in Ampara.29 officers participated and expenditure incurred was Rs.80,390/-. At these workshops the sessions were conducted under the topics; team building, social work, Case management, Case conference, and basic skills in counseling and reporting.

Preparation of Training Modules

TOT training module (English) was completed and skill development training module (draft) was prepared during the period.

Income Generating Support to Vulnerable Families with children

By the end of the year 2013 assistance was given to 44 vulnerable families in Mullaitivu, Trincomalee and Ampara Districts for income generating activities. Total money released was Rs.1,174,505/-.

The estimated provision has been increased by Rs. 2,159.37 Mn. over the same in 2012 due to Rs 123. Mn. for the "Dirisaviya", a new project proposed under 2013 budget proposals and Rs. 2,847 Mn. for welfare programmes in this year and Rs.1300 Mn. for increasing Rs. 1000/- monthly allowance for 230,000 Samurdhi recipients and Public Assisted elders over 70 years.

3. Obtaining and Management of Imprest approved by the Department of Treasury Operations.

4. Preparation of monthly salaries and allowances of the staff of the Ministry and making payments.

Rs. 100.05 Mn. has been allocated for staff salaries and allowances in the year 2013 and total expenditure for salaries and allowances at the end of December is Rs. 97.12. Mn.

- **5.** Preparing all other recurrent and capital payment vouchers and confirmation/settling and accounting under the Heads concerned.
- **6.** Preparation of monthly accounting summaries, maintaining records and submitting monthly records to Public Accounts Department and to the Auditor General.
- **7.** Releasing Distress loans and Festival Advance to the ministry staff, recover installments and interest thereto and to maintain Administrative Account and documents of it.

A sum of Rs. 4.00 (Mn) has been paid under Public Officers' Advance Account by the end of December 2013. The recovery in advanced account is around Rs. 4.37 Mn.

- 8. Settling in all due receivables to the Ministry, remitting them in banks and accounting under the income Heads concerned.
- 9. Preparation of annual Appropriation Accounts and submitting it to the Auditor General before 31 March in each year. Receiving Allocations under annual budget estimates through Appropriation accounts and acquiring assets in the year concerned for which accounts on overall expenditure is submitted, Inclusion of reports on disposing assets as well as details of liabilities.
- 10. Continuing the procurement process in purchasing items and services for the year 2013 and attending co-ordination works thereto.
- 11. Replying to all audit queries on expenditure and Auditor General's reports and attending co-coordinating activities thereto.
- 12. Conducting Board of surveys, updating documents and identifying disposable items and disposing them off. Accordingly having identified the items to be disposed in 2013, the action has taken to do so.
- 13. Maintenance of utilized and capital items stock of the ministry, issue of stock and it's management.
- 14. Having prepaired the ministry expenditure monthly and progress quarterly, submit them to Planning Division. Further it releases provisions to pay the allowance to the

disabled and salaries of the officers who serves at 331 Divisional Secretariats scattered in 25 district secretariats.

15. Supporting to institutes such as National Social Development Institute, National Board and Secretariat for Handicapped Persons, Community based Rehabilitation programme for Handicapped Persons, Social Development Management Information System, Social Development, Providing self employments to single parented families, National Consultancy Programme, Social care Centers and Aid programme between the UNICEF and Sri Lankan government for keeping accounts and directives on financial management had been extended in the year 2013.

The Accounting division has contributed its best to development process of the country by taking action to update accounts whilst maintaining financial management in social development drives that has been entrusted to the Ministry of Social Services in the year 2013.

09. Planning and Monitoring Division

Introduction

The objective of the Planning & Monitoring Division of the Ministry is to prepare development plans & programmes in consultation with the relevant stakeholders such as Government Departments, Institutions, Donors, NGOs and Community Based Organizations in accordance with the government policies and priorities. Collection of relevant data & information in relation to the social sector is also a responsibility of this division.

Functions of the Planning Division

The following specific functions are performed by the Planning and Monitoring Division of the Ministry;

- Formulation of policies relevant to the subject area of the Ministry in consultation with relevant stakeholders. - "Family Policy for Sri Lanka" has been prepared since 2012 and is expected to finalized soon.
- Preparation of Annual Action Plan for the Ministry in line with the Government priorities and Mid Term Budgetary Provisions. - Action Plan for the Ministry for 2013 was prepared in 2012.
- Preparation of quarterly progress reports against the annual action plan of the Ministry. – Three quarterly reports were prepared in 2013
- Preparation of performance report of the Ministry in order to submit to the Parliament. The performance report for 2013 with the progress up to 3rd quarter was prepared.
- Preparation of annual performance report of the Ministry. Annual Performance Report 2012 was prepared in 2013.
- Preparation and Implementation of the Action plan relevant to SAARC Social Charter. Three quarterly reports were prepared in 2013.
- Reporting to the Presidential Secretariat the progress of the activities assigned to the Ministry of Social Services under implementation of LLRC action plan.

- Preparation of reports required by various authorities in relation to the social sector.
- Preparation of new project proposals for the well being of the vulnerable group of the community in line with government priorities.
- Follow up actions on decisions taken at the discussions and seminars conducted with World Bank, UNICEF, UNPFA, WFP, WHO, UNV and UNDP

In addition to the above the following activities were also successfully completed by the planning division in 2013.

Main Activities

"Samaja Sewa Puwath" Quarterly News Letter

A Quarterly newsletter titled "Samaja Sewa Puwath" is also published by this Division. The newsletter provides information on development activities accomplished and services provided by the functional divisions of the Ministry. The news letter also reflects activities, special social events of the functional wings of the Ministry and presents articles relevant to Social Services. It is distributed among other line Ministries, Institutions and District Secretariats and Divisional secretariats. "Samaja Sewa Puwath Special Edition" was published in March, 2013 in parallel to the Deyata Kirula exhibition.

Re formulation of Family Policy for Sri Lanka

A policy document titled Family Policy was prepared in the year 2012 to provide policy guidance in enhancing the lives of disadvantaged groups in the country. As per the observations of His Excellency the President, a team headed by Prof. Karunarathne is reviewing the policy paper in order to give a broader view to the policy. The Planning Division coordinates the activities in this regard.

Implementation of "Dirisawiya" project

"Dirisawiya" project is being implemented under the World Bank fund with a view to provide financial assistance and vocational training for Persons with Disabilities. The Planning Division monitors the project.

Establishment of a Volunteer Secretariat

The Volunteer Secretariat within the Ministry was established in collaboration with the Ministry of Finance and Planning, UNDP and UNV in 2013. The Planning Division made all preliminary works in this effort.

10. Internal Audit Division

Introduction

The internal audit division of the Ministry of Social Services is functioned under a Chief Internal Auditor who is directly responsible to the Secretary of Ministry as per F.R.134(1). The Division consist of a staff with two Internal Auditors. (Development officers)
