### Participatory Action Research on Capacity Building for Social Care Workers in Collaboration with the Salvation Army

This action research project for social care workers is the outcome of a combined effort made by the institute of Salvation Army and the NISD. The idea to commence this programme was mooted by the Salvation Army. It is an International Human Service Organization (INGO). It has been providing caring services to the underprivileged in Sri Lanka for over 125 years in the past.

This project is currently engaged in the subject areas of social development, Human services, child and adult care, poverty reduction, spiritual development etc. This is a one year programme organized by the Social Development, Policy, and Research and Publications Division, of the NISD. This action research project is to be undertaken for the social care workers employed by the Salvation Army.





This programme aims to upgrade the knowledge base and skills of the relevant officers with a view to improve the delivery of social services most efficiently to the needy particularly children and older people.

### **Psychological Counseling for Human Development**

The counseling process reflects the need for one person to seek out help or advice from another person. Counseling as a professional occupation, therefore, derives not from the clinic but from other social settings. It helps persons resolve problems but counseling psychology on the other hand as a sub category of psychology is unique in its attention both to normal developmental issues and to problems associated with physical, emotional, and mental disorders and psychological counseling is used in many situations including the promotion of mental and physical health that contribute to human development

Psychological counseling focuses on therapeutic treatments to clients experiencing a wide variety of symptoms. It is also one of the largest specialty areas with in psychology. Psychological counselor facilitates personal and interpersonal functioning with a focus on emotional, social vocational, education, health-related, development and organizational concerns. Moreover psychological counselor focuses attention particularly on individual, family and group problems. The understanding of this specialty is therefore very essential when launching human development programs

Fundamentals of psychology deals psychology based human behavior, perception, sensation cognition, learning, motivation, emotion, intelligence, memory, forgetting, human development stagers, and personality when a person's perception cognition, memory and emotions are unbalanced, his/her behavior becomes abnormal. Here the psychological counselors use knowledge on *abnormal psychology*. According to that discipline psychotic disorders play the main influence for human development. Social psychological not only that psychological approach, testing, diagnosis systems and treatment are also very essential.

Psychological factors directly influence human behavior. The benefits of Psychological counseling concepts are therefore very useful in human development programs.

### What is Social Care?

Social Care means helping people live their lives comfortably, particularly those people who require a certain degree of extra practical and physical help. Social care workers endeavor to provide this service of practical support with a view of helping individuals maintain their independence, to increase their quality of life and to help them lead fuller more enjoyable lives.

Social care workers also work with children and adolescents in institutional care, people with learning or physical disabilities, people who are homeless, people with alcohol and drug dependency, families in the community and older People.

It provides professional care, protection, welfare and advocacy for vulnerable or dependent clients, individually or groups. This is achieved through the planning and evaluation of individualized and group programs of care which are based on needs, identified where possible in consultation with the clients and delivered through day to day shared life experiences. All interventions are based on established best practice and in-depth knowledge of life span development.

#### Social Care Value base

The care Value is a set of rules and guidelines that every care practitioner has to follow in order to provide services to their clients. The seven principles that they need to follow are:

- ➤ Promote anti –discriminatory practice.
- > Maintaining confidentiality of information.
- ➤ Promote and support individual's right to dignity, independence, choice and safety.
- Acknowledge people's personal beliefs and identities.
- Protect individuals from abuse.
- > Provide effective Communication and relationship.
- Provide Individualized Care.

The core value base should be used by the care workers when working with people. The clients have the right to their own benefits, ideas and way of life which the care workers should try to adhere to. Nobody has the right to damage other people's quality of life. Rights come with responsibilities. Care Workers respect the rights of all clients, no matter what clients are in need of care. They should be supported by effective communication and be able to interconnect with a person effectively. It helps increase the quality of care.

## To give meaning to an empty word...... To fulfill a broken promise.......

As delineated by UNICEF, "Childhood is the foundation of the world's hope for a better future" (UNICEF reports, 2005 p.01) and childhood means 'The time before a person is considered an adult (UNICEF reports, 2005 p.03). In other words for a better world, every child should have a better childhood as childhood is the foundation of the world's hope for a better future (UNICEF reports, 2005 p.01). But in the first instance, as the report indicates, "Childhood is an empty word and a broken promise".

Owner of childhood is a child. Hence the empty word or the broken promise is meant for children. Thus the world's hope for a better future collapses when a number of social injustices and ill-treatments against children are condoned. The Convention on the Child Rights says, "Every child has the right to non-discrimination, survival and development, protection from illicit transfer and illegal adoption, protection cofrom abuse and neglect, education, a decent standard of living, dignity and worth even if the child has infringed the aw, etc" (Articles 1-40 of the Convention of the Rights of the Child).

Although the Convention consists of such rights, the prevailing conditions in the world prove that the child, who is considered as the future citizen, is highly deprived of not only the basic needs such as food, access to education, safe water, sanitation facilities, shelter and right to enjoy them but the right to live. As a result, child in the present world is abused both physically and mentally.

Majority of every day reports on media about such incidents indicate that children become victimized due to the fault of adults. As mentioned in a newspaper, "The reason for many such cases can be the myth behind child abuse cases, i.e.the dangers to children coming from strangers. In most cases the perpetrator is someone the parent or the child knows and trusted by the child and the family" (Daily News, 08/09/2011). Moreover in most cases, such victimized children are the ones who are deprived of basic physical needs such as food, sanitation facilities, and shelter and even the right to live. Only a few of them do not fall into this category.

There are a number of laws dealing with offences against children, child labor and issues relating to juvenile justice. Undoubtedly these laws protect victimized children from being further abused to a certain extent. However the statistics related to child abuse cases or deprivations of child's needs and rights further prove that the prevailing laws alone cannot hold back the injustice done to children.

Furthermore the complications and limits in jurisdiction have indirectly worsened the conditions of children. "Child rape carries a minimum mandatory jail sentence of 10 years. Grave sexual abuse on a child is also punishable with the same mandatory jail sentence of 10 years. However there is non-summary inquiry in grave sexual abuse cases and suspects can be directly indicted. In the case of other offences of sexual abuse of children also which carry the same minimum mandatory sentence of 10 years rigorous imprisonment as in rape, no non-summary inquiries are conducted." (Child Abuse and Law; A review of the Law and the Legal Process, 2000 p.33)

Establishing laws can only punish the abuser or the accused but in most cases it never helps rebuild the child's broken life. As the foundation of the world came to be threatened, the world started paying more attention to this. As "Prevention is better than cure"; the world has to take necessary steps to strengthen the protective cover around the child, specially the family of the child. Also as education is the formal base for a proper personality, a child should be inculcated with good morals at schools. Even the media has a huge responsibility. Instead of portraying evil (star contests, soap operas etc.) the media has to make the society more aware of such preventable issues Practicing religion helps to inculcate morals and live in society peacefully. Concern with arts and nature guide people for a better way of living. To for that the media and the education system should be restructured including such lost values.

If not, the empty word or the broken promise will remain as it is, letting the world suffer forever.

Aging is the accumulation of changes in a person over time. Aging in humans refers to various processes of physical, psychological and social changes. Aging is a social construction and it associates with other social activities in our life. There are many myths surrounding aging, they are

- ✓ Aging means Alzheimer's
- ✓ Aging means no contribution to society
- ✓ Aging means physical incapability
- ✓ Aging means end of learning
- ✓ Aging means loneliness and deprivation

Different societies define aging differently and use different indicators.

- ✓ The Arunta Tribe in Australia identifies a person who has reached more than fifty years of life as an aged person.
- ✓ In the Eskimo community when a man is no longer able to hunt is considered an aged person.
- ✓ The Bush people in South Africa recognize a person who had children with grey hair as an elderly person.
- ✓ In the modern societies aging depends on pensionable age criteria and they divide the old age into three types as young old (65-74), middle old (75-84) and oldest old (80+).

Population aging is the increase in the number of older people in society. The change occurs through migration, longer life expectancy (decreased death rate) and decreased birth rate.

The elderly population usually faces problems as they become non-productive and physically incapable Psychological Problems, Economic Problems, Health Problems, Housing Problems and Nutrition Problems are common among them.
