Introduction

Ministry of Social Empowerment and Welfare was established in accordance with the Gazette Extraordinary of the Democratic Socialist Republic of Sri Lanka, dated 21.09.2015 by setting up its mission on the providence of efficient, productive and friendly Socio – economic service to improve the living standards of the marginalized and under privileged groups of people.

This Ministry, to be the most respected model Ministry in the South East Asia in creating poverty free, right protected Sri Lanka by 2030, renders an immense service together with its above vision among several key target groups which are benefitted with the services rendered by Ministry and they are;

- Persons with Disabilities (8.7% among the total population)
- Senior citizens over 60 years of age (12.4% among the total population)
- Single Parent Families (11.8% among the total number of families)
- Low-income families (6.7%)

Department/ Institute/ Sectors Under the purview of the Ministry commit a lot for the social and economic development.

Department of Divineguma Development is the massive Development movement which provides the strength for enforcing the national policy of certifying the eradication of poverty and social equality towards the promotion of economic development process.

The Department of Social Services commits to undertake the tasks of skill development of the persons with disabilities and make them independent citizens and early intervention in cases of children with special needs.

The main role of the National Secretariat for Persons with Disabilities is to promote the rights of the persons with disabilities including their welfares facilities for creating conductive environment for the disadvantaged people in the Society.

The National Secretariat for Elders provides necessary contributions to elders in Sri Lanka through various programmes for creating freedom, protection, self-achievement, participation and dignity for them as well as to offer due rights for the elders.

For the purpose of satisfying the country's requirement of professionals in Social Work and Social Welfare, the National Institute of Social Development is engaged in providing the education in Social Work as its key academic discipline.

The Single Parent Families Development Programme is being implemented under the Ministry for the purpose of assisting the poor Sri Lankan citizens who become single parents due to various reasons.

Rural Development Training & Research Institute makes a significant contribution to empower the community and maximize their active participation in the sustainable rural development, through research, training and compilation of information.

Sri Lanka Social Security Board provides the pension and social security benefits to all employees who need the coverage of the government pension including the self – employed persons, senior citizens, dis advantaged persons, single parents, foreign employees and artists.

In this way, this Ministry provides the active contribution by means of social and economicassistance for poor people, elders, single parents, drug addicted persons and orphans in the Society. Accordingly, the progress of the Development programmes implemented by the Departments/ Institution. Divisions of this Ministry, which is dedicating for the development of the country, up to 31st of August 2016 is included in this "Achievement" book.



02. National Council and National Secretariat for Persons with Disabilities

Mission

Promotion, improvement and assurance of the rights of Persons with Disabilities through the guidance, coordination, implementation and monitoring of the development activities

2.1. Introduction

The objective of the National Secretariat for Persons with Disabilities is to make legal provisions relevant to Act No.28 of 1996 enacted for the Promotion, Advancement and Protection of Rights of Persons with Disabilities in Sri Lanka and to provide for matters connected or incidental in that regard.

2.2. Functions

The National Council for Persons with Disabilities has been established for the purpose of making decisions with regard to rehabilitation of the persons with disabilities and implementing the legal provisions related to enforcing the National Policy on providing welfare and relief to them with a view to realizing the objectives of the above Act. In line with the decisions thus taken, the National Secretariat for Persons with Disabilities (NSPD) carries out the following activities:

- Poverty minimization and rehabilitation based on promotion of welfare of the persons with disabilities.
- Prevention and control of main causes of disabilities.
- Maintaining accurate data and statistics on persons with disabilities.
- Supervision, guidance and assistance when needed, for the institutions established for development and welfare of the persons with disabilities.
- Facilitating the access to inclusive development, preparing the physical environment and providing the relevant parties with direction, guidance and assistance when needed.
- Implementing programmes to ensure the continuous education of the children with disabilities who are at their due age for receiving education and currently going to school and such children who are currently not going to school and assisting them in their needs.
- Implementing Programmes to raise the public awareness about the social responsibility to incorporate the contribution of the persons with disabilities into inclusive development and programmes for carrying out promotional activities in that regard.

• Identifying the (Geographical) areas where the persons with disabilities occur in relatively higher numbers and implementing programmes to draw the public attention towards the factors causing such disability and carrying out follow-up actions and analyzing the progress of the programmes thus implemented.

2.3. Financial and Physical progress (as at 31.08.2016)

2.3.1. Implementation of the legal provisions for protecting rights of persons with disabilities.

* A new draft bill to provide for protecting rights of persons with disabilities

The new bill, which has been drafted by a special drafting committee for further improving the Protection of Rights of Persons with Disabilities Act No .28 of 1996, has been submitted to the Legal Draftsman's Department for necessary actions.

Sign Language Draft Bill

The Sign Language Draft Bill prepared following the recognition of the Sign Language by the Cabinet of Ministers as an accepted language, was submitted to the Department of the Legal Draftsman and as of now, a preliminary draft prepared by the Legal Draftsman has been forwarded to the Ministry. As per the suggestions calling for further development of the draft bill, the National Council recommended obtaining views and suggestion from a committee of subject experts and such views and suggestions have now been referred to Legal Draftsman.

* Draft Bill for Protection of the Rights of the White Cane Users

Since the rights of the visually handicapped are also protected by the Act No.28 of 1996 for Protection of the Rights of the Persons with Disabilities, the Legal Draftsman has informed that it is suitable to prepare a set of rules under the same Act rather than preparing a new Act for protection of the rights of the visually handicapped.

Ratification of the United Nations Convention on the Rights of Persons with Disabilities

The international Convention on the Rights of Persons with Disabilities was adopted by the United Nations General Assembly on 13 December 2006, in accordance with the United Nations Universal Declaration of Human Rights and International Human Rights Treaties, Sri Lanka is a signatory to the said UN Convention. In Subsequence the Cabinet Memorandum in connection with the ratification of the international convention on the rights of persons with disabilities was approved on 23. 12. 2015.

Accordingly Sri Lanka was declared as a country which ratified the international convention on the rights of persons with disabilities by the UN on 08. 02. 2016.

2.3.2. Self-employment assistance for income generation.

Under this programme, with a view to poverty minimization of the low-income families with members with disabilities, such families or individuals are provided with a financial assistance up to a maximum of Rs.25, 000/- to start or develop a self-employment, and necessary arrangements are made with regard to starting of such self-employments monitoring the progress, improving the quality of the products and assistance with selling of products.

2.3.3. Monitoring of Welfare and Development Centers

Implementation of programmes for supervision of quality, regulation, and providing assistance when needed, with regard to the Welfare and Development Centers maintained by the voluntary organizations registered with National Secretariat for Persons with Disabilities. There are 130 of such centers being maintained by those registered institutions.

2.3.4. Providing Accessibility Facilities for the Persons with Disabilities.

All existing public buildings, public places and places of public service delivery shall be made accessible to the persons with disabilities, as per the Accessibility Regulations: No.01 of 2006 promulgated by the Gazettes Extraordinary No 1467/15 on 17.10.2006 and No 1619/24 on 18.09.2009 in accordance with the Protection of the Rights of Persons with Disabilities Act No. 28 of 1996.

However, having appointed the committee headed by the Ministry of Social Empowerment & Welfare and with the participation of Urban Development Authority, Ministry of Transport & Civil Aviation, the Sri Lanka Institute of Architects, Department of Urban Engineering, Road Development Authority and etc a report is being prepared for amending the regulations in the said Gazette Extraordinary notification because the specifications therein should be amended to be suited to more comfortable for the persons with disabilities and for the current needs.

2.3.5. Rs.3000/- Monthly Allowance for Persons with Disabilities.

The programme for providing a monthly living allowance of Rs.3000/- to the low-income families with disabled members is implemented since 2007. Factors such as poverty in the family, severity of the disability, householder being disabled and the number of members with disabilities in the family are taken in to account in granting the allowance.

It has been revealed through field observations that the economic, nutrition, mental and social levels of the persons with disabilities and their families have been improved with the assistance received under this programme.

2.3.6. Monthly Living Allowance for Kidney Patients

As a measure of easing the difficulties encountered by the people suffering from Kidney Disease in obtaining their medicine or travelling to attend the clinics, 19,599 of kidney patients undergoing blood purification have been selected for a monthly living allowance of Rs.3000/-with the recommendation of the Ministry of Health, from Kurunagala, Ampara, Vavuniya, Badulla, Matale, Monaragala, Polonnaruwa, Mullaitivu, Anuradhapura and Trincomalee districts where the Chronic Kidney Disease is highly spread.Out of those selected, 13,533 patients were receiving the allowance by 31.08.2016.

2.3.7. Educational Assistance

The children with disabilities and children of parents with disabilities, of low-income families are provided with the educational assistance up to a maximum of Rs.10, 000/-as a one-time payment, for the purpose of meeting the traveling expenses to go to school and obtaining educational materials. The field officers have confirmed that due to the educational assistance provided under this programme, there is an improvement in the tendency among the children with disabilities at the school-going age to have education.

Actions are taken to provide the monthly assistance of Rs. 1,000 /= under the sponsorship of the President Fund to low income A/L Students who lost rether mother or father due to kidney disease. Acordingly, by 31/08/2016, Rs. 415,000 was given to 110 children.

2.3.8. Provision of Assistive Devices

In order to making disable people contribute to their own inclusive development and to make them independent persons, while assisting their rehabilitation activities financial assistance is given to obtain the Spectacles, wheel chairs, hearing devices, tricycles, crutches, wheel chairs and etc of the persons with disabilities. These equipments were provided to low income persons upon the medical recommendation in this year as follows and 45 mobile service programmes were held for this purpose.

2.3.9. Housing Assistance Programme

Housing assistance is provided, subject to a maximum of Rs.250, 000/- each, for building a new house or a part of the house for a low-income person with disabilities who has no house to live in or for the family who take care of such person, or for repair of a house, subject to a maximum of Rs.150, 000/- each. For the purpose of providing assistance under this programme, 5% of the income from sale of the Supiri Vasana Sampatha lottery is currently credited to the National Fund for Persons with Disabilities. Accordingly, as at 31.08.2016, a sum of Rs.35.995 million has been expended in respect of 375 houses.

2.3.10. Medical Assistance

Under the Medical Assistance programme, a family living on an income less than Rs.6000/- a month is provided with a financial assistance up to a maximum of Rs.20,000/-each on priority basis for the purposes such as obtaining medicines not provided by government hospitals to persons with disabilities and those who suffer from long-standing illnesses, meeting the travelling expenses for attending clinics, expenses incurred for heart, eye, kidney, brain, hip bone transplant, ear drum surgeries, purchasing special medical equipment such as water mattress, air mattress and speech aids and for blood transfusion.

2.3.11. Courses

Ability to Communicating with persons with disabilities is particularly important in satisfying their service requirements. National Secretariat for Persons with Disabilities has started a training programe on Sign Language, Braille Methodology, Mobility and Orientation for public officers to enable them to discharge their duties in a more productive and efficient manner. In 2016, one such course was conducted for a group of 50 officers.

2.3.12. Provision of Assistance to Care Homes.

A provision of Rs. 8 million has been released to meet the expenses of water and electricity bills and salaries of the employees of the Victoria Home at Rajagiriya which gives refuge to a large number of persons with disabilities who are incurable and requiring life-long care.

2.4. Special events

A sum of Rs. 3.00 million has been provided for development of facilities of 11 institutions engaged in the welfare of persons with disabilities and Rs 2 Million has already been spent on this purpose by 31.08. 2016.

03. Single Parent Families Development Programme



03. Single Parent Families Development Programme

3.1. Objective

The number of Single parent families is increasing in the society at present. The objective of this programme is to improve living standers of the under privileged SriLankan citizens who have become single parents due to the spouse and children being deserted by their parents or due to long term imprisonment for their spouse or due to the untimely demise of the spouse by assisting them in trickling their economic difficulties.

3.1.1. Selection to Beneficiaries

- Women with underage children and school-attending children, who have become vulnerable due to terrorist activities, communal war situation, accidents, suicides or untimely death of their husbands.
- For families of which wife and children have been deserted by husband or, husband and underage children have been deserted by wife.
- For those women who are not legally married but have underage children and schoolattending children and without sufficient means of income to satisfy the needs of these children.

In selecting beneficiaries under the above criteria, priority is given to families with breast feeding babies and school-attending children.

As per the data issued by the Department of Statistics in 2012, total no of single parents families in Sri Lanka is 610,945. The most vulnerable group among them is the small children and women. For the reason that there is a severe threat for their protection security and dignity.

Further, according to a study done by the Ministry of Education, it has been revealed that 2% of children at the school-attending age are not attending to school mainly due to poverty. A considerable portion of this group is from Single parent families.

For alleviating this situation, the following activities are carried out under this programme.

1.Organization of work

- I. Conduct training and awareness programmes required to start and continue to selfemployment for self-employments expected people.
- II. During these programme these people would be educated on selection of suitable selfemployment the financial management knowledge of finding the market and mental strength.

2. Providing Assistance

I. The family who are interested on starting self-employment are provided with the assistance of Rs.25,000/-

II. Provide necessary guidance and financial assistance for improving the selfemployments further more for those who

- I. Having selected a Divisional secretariat where single parent families are commonly living, implement a suitable programmes to develop single parent families in the area.

04. Rural Development Division

4.1. Introduction

Aims of this programme are to refer the rural people to livelihood development projects through empowering them for uplifting the community life, Develop the infrastructure facilities for this purpose, promote rural industries by utilizing the resources on the villages as appropriate, encourage people to cultivate organic and toxin – free production and to consume fresh fruits, make rural people good citizen through developing their spirit and values, create conducive and safety environment which is favorable for everybody to live and to reduce the poverty in the village and it is expect to develop one village in each Divisional Secretarial Division as an exemplary pilot village under this programme.

Under Stage I of this programme, at least one village in to one District amounting to 37 villages have been selected.

When selecting the villages for this programme, the attention is drawn to a potentially of improving all sections including the economic, social, cultural, spiritual, environmental and etc in the village and a high density of low income people in the area and when converting to a prosperous village, it should be considered the attitudes and efficiency of the rural people, as well as Officers and parties who work related to the village.

The Department of Divineguma Development allocates around Rs.6.0 Million for each Village for implementing this programme. Monitoring, supervision and follow up activities of this programmes are carried out by the officers, who serve in the Rural Development Division of this Ministry under the provisions of the Department of Divineguma Development. This programme is implemented by the officers, who are directly related to the village including Economic Development Officers in the Divineguma Development Division of District Secretariats and Divisional Secretariats, Grama Niladari Officers, Divineguma Development Officers, Agriculture Research and Production Assistants and Midwives etc.

5.1. Introduction

D

The Department of Social Services was established on 1st February, 1948 and at the beginning it was restricted to provide the services to groups of people who faced disadvantaged and marginalized situations in the society. Therefore, the people living in that society acquired a psychological dependence. Presently, the Department of Social Services has converted through various subject scopes to bring these people in to the society by creating a social environment with necessary economic opportunities to accommodate such isolated people.

The Department of Social Services, which is in the firm mission of making those who are subject to the disadvantaged situation in the society, active stakeholders in the national development process by providing needy services and empowering them, has achieved a satisfactory progress within the provisions provided by the General Treasury for the development activities.

The target group of our field of activity includes male and female youth with disabilities, youth who have been addicted from drugs and who have been driven from the normal life to undergo various problems and disabled persons who require specialized equipment to live along with others in the society. The Department of Social Services which is committed to the course of creating an independent life style for disabled persons as arrange to provide vocational training, equipment to engage in an occupation, referral to provide employment opportunities, artificial limbs, to provide Identity Cards to ensure identity and to safety for persons with impaired vision. In addition, it provides individual consultancy services to drug addicted persons, family

consultancy services, and the public is made aware of these services which involves awareness program. Very satisfactory performance was achieved in the repair of buildings belonging to the Department, renovation of vocational training institutes, purchase of required capital goods and specially the renovation of vocational training institutes and purchase of required equipment's. It is scheduled to complete the proposed constructions of Amunukumbura Vocational Institute and to entrust in the hand of new disabled trainees. Constructions activities of Thelambuyaya Vocational Institute have been reached to the final stage.

Local and foreign trainings and researches for capacity development workshops were conducted to improve the knowledge, skills and attitudes of the staff for upgrading the service provided by the Department of Social Services. For the purpose of broadening the subject scope of the Department, some projects hone been submitted to the General Treasury with a view to doing research and to implement such projects in the year 2017. Specially, the service network which to be provided through the combined approach from national level to grass root level with field officers of all institutions under the Ministry of Social Empowerment & Welfare, has been strengthened.



5.2.3.1(a). Vocational TrainingCenters under the Department of Social Services



This project is implemented in 08 Vocational Training Institutes naming Seeduwa, Amunukumbura, Ragama, Madampe, Ketawala, Wattegama, Vibhavi and Thelambuyaya, which are established in 06 districts of Colombo, Gampaha, Kandy, Puttalam, Rathnapura and Hambantota. The disabled young children between the ages 16 - 35 are eligible to follow these training courses. Training period is around one year and during this period they are provided with the required foods, accommodation facilities, health facilities and the training on free of charge. In addition to such facilities they are provided with an allowance to meet their daily expenses. Moreover they have an opportunity of improving their art skills and other activities and which is a fringe benefit of this training. The trainees, those who have successfully completed the training would be given the recognized certificates and tool kits for the self-employments. They would be introduced the job opportunities in both government and private sector as per the training they have obtained and follow up activities of such trainees, those who have been associated with people in such way, would be done by the officers in their training institutes.

In addition to the vocational training, providing special identity cards to the persons with hearing disabilities, providing allowances to the trainees, who are learning at the voluntary institutions, which provide the vocational trainings, providing allowances to the pre - school teachers, who teach the children with hearing disabilities and low intelligence, granting maintenance aids and ad hoc aids to the voluntary social institutes which receive financial assistance from the Department of Social Services and providing the sign language service to the persons with hearing and speaking disabilities are done by the Department subject to this project.

In addition to the improvement of the professional skills of the trainees these disabled youth will get an opportunity to share their knowledge, skills and experiences on the technology, communication, art and sport with others. In the year 2016, about 350- 400 trainees will be completed the training successfully. According to their follow up activities, the professional knowledge they improved through the training has successfully been used to improve their livelihood activities.

In addition to the providence of the vocational training, issuance of special identity cards for the persons with hearing disabilities, providence of trainee allowance for the trainees learning at the voluntary social services institutions for the persons with disabilities, providence of allowances for preschool teachers of hearing impaired and mentally restarted children, providence of maintenance assistance and ad hoc assistance for the voluntary social services institutions, which are under the Department of Social Services and providence of the sign language services are also done.

5.2.3.1(b). Jayaviru Sewana- Puwakpitiya

Department of Social Services runs an institute for providing protection and residential facilities to the mentally restarted boy children who lost their parents and guardians. The said institute is located in Puwakpitiya and that can provide services for 75 children, at a time.

These children are been cared very lovingly without putting them in loneliness and they are referred to the day to day activities. There were 68 children obtained services by 31.08.2016.

5.2.3.1(c).Child Guidance Center at Maharagama

A doubted situation arises if a growth defect or a stunted growth of a child is in the family or when a child is identified as having some disability, the child should be referred to the Child Guidance Centre. This is the institution, which is located in Nawinna, bears the state responsibility by means of raising parent's mental level, early intervening towards the development of the child, providing basic services and coordinating the heath, early child hood, education and welfare services. Accordingly, the children, those who are benefitted with the services of this project, will interact to special educational units or normal schools following their proper development

The parents, who seek the correct guidance towards their children, are initially registered by having obtained the bio data of such children. Having identified the needs of the child, estimation is taken on the basic growth condition. After having the discussions between teachers and parents the children are referred to the suitable class room as per the skills of the children following the preparation of the detailed quality report. 5.2.3.1(d). Jayawiru Samadhi (Drug Addicts Rehabilitation and Socialization Project)

This home provides several preventive and rehabilitation programmes to drug addicts and persons to be addicted to drugs. At present, these addicts are treated through the residential rehabilitation programmes, anti-toxic treatments, skills development and mental treatments and so on at the Jayaviru Samadhi Home.

Samadhi Home has been upgraded as a treatment center to rehabilitate drug addicts through psycho therapeutic & psychological counseling methods and medical scientific approach. . About 80% among the beneficiaries represent the Western Province and majority of them were Heroin addicts. The rest addicted to Ganja, Alcohol, Intoxicated tablets and Tobacco. These beneficiaries were of different age groups varied from the age of 16 to 55 years. About 80% of the affected persons were of among the age group of 16 to 35 years. Their rehabilitation time period may be varied from three months to one year. During the training period they have the opportunity follow different courses, like Refrigeration and Air Conditioning Mechanics, Welding Technology, physical education, Yoga exercises, Agriculture, Home gardening and animal husbandry, religious programmes, counseling and meditation programmes. Courses like Refrigeration, Air Conditioning Mechanics, Welding Technology and etc are conducted for the development of the livelihood activities of those service gainers. There were 74 service gainers, who have been rehabilitated by August 2016.

5.2.3.2. Visually Handicapped Trust Fund

The positive commitment to the growth of new attitudes has been gradually arisen on the disabled persons in Sri Lanka following the declaration of 1981 as the International year of Disabled Persons (IYDP). As a sequel to this direction an Act of Parliament No 09 of 1992 to establish a fund for visually impaired persons was passed by parliamentary of the Domestic Republic of Sri Lanka. This was published as a Gazette Notification on 6th March 1992. The Government of Sri Lanka has initiated various services in support of the disabled persons in Sri Lanka in line with this Act.

Visually Handicapped Trust fund is being implemented by the Management Committee. The secretary to the Ministry of Social Services becomes the chairperson-in-office until the next secretary to the Ministry will be appointed. The management committee will meet once a month. Activities of the fund are audited by the Auditor Generals' Department and Internal Audit Division of the Ministry.

The mission of this fund is inter alia to provide required services to persons with visual impairment rehabilitate and provide relief. Specialty of this fund is the creation of equal opportunities to visually impaired persons and takes action in pursuance of the rules and regulations convinced by the united Nation



During the beginning of the final quarter of 2015, it had been decided to hold an island wide census to identify beneficiaries who really deserve the Samurdhi subsidy, and 2.5 million census forms in this respect had been printed and distributed.

Progress

Under its first stage, survey activities in respect of 1,430,000 families that are already receiving Samurdhi subsidies had been finalized, and under the 2nd stage, data had been obtained from 1,004,040 persons in order to identify a fresh people who are eligible to receive the subsidy.

By now, computerization of the data of the above survey has commenced, and a sum of Rs. Mn 1.60 has been spent as at 31.07.2016.

Rural Development Training & Research Institute, established in 1974, is the pioneering institute which applies participatory development methodologies for the National development programs. By implementing the Change Agent Program in 1978, RDTRI launched an Action research in order to experiment the Participatory Development Approach for the first time in Sri Lanka. Mission

To encourage participation of older persons on social development and to ensure their independence care, participation, self-fulfillment and dignity. Also to protect the rights of elders through awareness programmes

7.1. Introduction

ſ

The objective of this Secretariat is encouraging elders in Sri Lanka through various programmes for creating freedom, protection, self-achievement, participation and dignity for them as well as offering due rights of the elders. In reaching those aims, powers are vested with this Institute by the National Council for Elders by virtue of Act No. 09 of 2000 and by amended Act No. 5 of 2011on ensuring the rights of elders. The Programmes implemented for the well-being of the Sri Lankan Elder population are as follows.

7.2. Activities & Progress up to 31st of August 2016

• Financial Assistance for Elders committee

Provide financial assistance to Village Level Elders Committees/ Divisional level elder committees/ District level Elders Committees and Provincial level elders committees established as per Section16th and their supervision. By the end of 31st of August 2016, Rs 1.999 million for 325 village level elders committees (Rs.5000/- each), 01 Divisional level elders committees (Rs.7500/- each), Northern province meeting, North Western religious programs, Stationeries for 17 District elders committees have been spent under this programme

• Providing Eye lenses & Hearing Aids

Equipment's such as eye lenses/ hearing aids needed by low income earning senior citizens aged over 60 were provided. By the end of 31st of August 2016, the Total of incurred expenditure was Rs 5.957 million to grant eye lenses for 2444 peoples and hearing aids for 236 Peoples under this programme.

• Providing of Identity Cards for Elders

The Special Identity card provides for above 60 years senior citizens. Under this, 16,728 Elders Identity Cards have been provided for the Elders by the end of 31st of August 2016 and Rs. 0.370 million has been spent.

• Conducting of pre – retirement training and awareness programmes

Consultancy services are provided for improving mental health of elders through retirement training programmes for peaceful retirement life for employees of all sectors who are in retirement age. Further workshops for elder's committee members, other organization and care givers (Home-base Attendants) who handle care of aging elderly citizens are also conducted. By the end of 31st of August 2016, Incurred expenditure was Rs.4.400 million for conducting 120 awareness programes for School Children's, 121 awareness programmes for woman's organizations, 08 awareness programmes regarding 2000/- allowances, 02 care giver awareness programmes, 01 friendship exchange programme, o2 Progress evaluation meetings.

• Maintenance Board

Taking actions to refer helpless parents to the Maintenance Board for Elders established as per 24th section of the Act and taking initial steps to pay Maintenance.By the end of 31st of August 2016, 47 requests have been settled out of 75 and incurred expenditure for this purpose was Rs.0.700 Mn.

• Monthly allowance for Elders (Rs. 2000/=)

Public Assistance Programme of Rs. 1000/-for low income earning senior citizens is being implemented commencing from 2015 to provide protection and welfare to Sri Lankan citizens aged over 70. Under this, 386,080 elders are benefited.

• Financial Assistance for Elders Homes

Funds to develop infrastructure facilities in Elders' Homes are provided Island-wide. Under this, incurred expenditure was Rs 8.794 Mn for 09 Elders Homes by the end of 31st of August 2016.

8.1. Introduction

The National Institute of Social Development is recognised by the University Grants Commission (UGC) as a degree awarding Institute, under section 25 of the Universities Act No. 16 of 1978. It functions under the purview of the Ministry of Social Empowerment of Welfare. It is the premier institution in Social Work education in Sri Lanka producing professional social workers to serve the social welfare system and to promote social development. This Institute operates under the provisions of the National Institute of Social Development ACT No. 41 of 1992 In 2005 on the recommendation of the University Grants Commission, the Government of the Democratic, Socialist Republic of Sri Lanka, granted the degree awarding status to the National Institute of Social Development for the purpose of developing higher education leading to the conferment of the Bachelor's degree in Social Work. Subsequently the Master's Degree programme in Social Work was also approved and commenced in 2008. In 2013Commencement of Diploma, Higher Diploma and Bachelor's Degree in Social Work in Sinhala, Tamil and English medium according to trilingual Policy is a remarkable achievement.

The Organizational Structure of the Institute

The Governing Council is the apex body in the organizational structure of this Institute while

the Academic Affairs Board functions under the Council as an advisor body on all academic matters. The regular operational functions of the Institute are carried out by four integrated divisions. They are;

Construction of Building complex for NISD in Seeduwa

A land of 2.1493 Hectare (5 acres, 1 rude and 9.08 perches) from Seeduwa belongs to the Ministry of Social Empowerment of Welfare has been received to construct a permanent building for National Institute of Social Development. Cabinet approval has been received for One Billion rupees to construct the new building complex and allocated Rs. 500 million from the national budget of 2017.

The plan and the budget estimation for the new building complex have already been forwarded to the Department of National Budget.

Establishment of a Regional Training Centre in Kilinochchi

A Regional Training Center in Kilinochchi District was opened with the objective of extending the courses at the village level. Regional Centers in Ampara, Thalawa and Ranna have already been functioning and Kilinochchi Training Center was opened as the forth one at the Kilinochchi District Secretariat in January 2016.

Renovation of Training Centre Thalawa

The renovation work of Thalawa Centre has been completed and short and long term courses are conducted. Further accommodation and hall facilities are rented out for outside people and organizations.

Filling of the existing vacancies in the Institute

Necessary actions have been taken to fill the existing 24 vacancies at the NISD. Requested for the allocations form the 2017 budget.

Library Facilities

The Library of the NISD consists of over 20,000 publications and it is at present the largest library in Sri Lanka with reading materials related to Social Work. Details of books available in

the library have been added to a database system.

English Language Teaching Programme

The Institute conducts regular English language classes for the students registered (Sinhala/Tamil/English Medium) to read for the Diploma in Social Work / Higher Diploma and the Bachelor of Social Work degree programmes. In the first year, prior to the commencement of regular lectures, the students are required to follow an intensive course in English. Qualified and competent English instructors have been employed to develop the English language skills of students in order to enhance their ability to read books/documents/periodicals in English. The programme also assists undergraduates following the Bachelor of Social Work degree programme to reach the required level of proficiency in the English Language to qualify for the BSW degree.

Library Facilities for Regional Centers

NISD has initiated mini libraries for each Regional Training Centres in Ampara, Thalawa, Kilinochchi and Ranna and the supervision and the responsibilities of inventory has been assigned to Library of the Institute and the stores.

Upgrading NISD to the status of University

The process of affiliating the NISD with the University of Sri Jayawardenapura is in progress and activities will be begin officially after signing the MOU between both Institutes.

Vision

Ensuring Social Security for a Dignified

Mission

Formulating, Executing and regulating provisions and policies aligned to practices of good governance to ensure Social Security of Sri Lankan citizens strengthening the economy and protecting cultural values, incorporating strategic alliance with government and nongovernmental organizations towards sustainable development for a dignified nation.

9.1. Establishment of the Institution

Sri Lanka Social Security Board has been established in accordance with the Act No. 17 of 1996 and subsequently the original Act was amended by the Act No. 33 of 1999.

This Social Security Board was first established under the purview of the Ministry of Social Services in the year 1996 and subsequently it was affiliated to the Ministry of Finance from May 2010. Later on, this Board has been executed under the authority of the Ministry of Social Empowerment & Welfare with effect from 21.09.2015.

Objectives

- To provide social security to self-employed persons during their old age and on disability
- To provide relief to the dependents of self-employed persons, upon death;
- To encourage self-employed persons to continue in their respective occupations and to develop their capabilities and skills
- To encourage youth to be self-employed and to develop their capabilities and skills
- To educate self-employed persons on the benefits of thrift and resource management
- To improve the living standards of self-employed persons generally.

The Role of the Board

The pension and social security benefits scheme is targeting the individuals, who do their own self-employments. Nevertheless, presently, in addition to the self-employed persons, there is a need and situation of implementing the pension and social security benefits scheme forthe employees in the private sector, foreign employees, artists, and for individuals, who engage in agricultural and fishing activities.

The pension and social security benefits scheme

Sri Lanka Social Security Board provides the social security to all, who need the coverage of the government pension during their older age and benefits like monthly pension to the spouse in case of death of the subscriber, partial disablement benefits and total disablement benefits before reaching the pension entitlement, death gratuity are implementing in - an- assured - manner.

Service fields, which have been covered

Presently the self-employment persons, the employees in the private sector, the employees in the Co-operative Services, the employees in the Statutory boards, Professionals, artists, Ayurveda medical practitioner, foreign employees, priests, indigenous people and all the others who need the care and security of the government pension scheme are covered by the Sri Lanka Social Security Board.

The Pension and Social Security benefits schemes, which have already been implemented

• For foremost function of Sri Lanka Security Board is to provide pension and social security benefits to those who are not entitled to a government pension. In accordance with the regulations made by the Sri Lanka Social Security Board Act No .17 of 1996, "Surekuma" pension and security benefit schemes was introduced by an Extraordinary Gazette Notification of the Democratic Socialist Republic of Sri Lanka dated 22nd September 2006 bearing the number 1464/5. All those who are in the ages of 18 to 59 years, not entitled to a government pension could be members for the schemes and be entitled to the possibility of drawing a monthly pension as desired to meet their requirements depending on the ability to pay the contributions to the Board.

• "Arassawa" preplanned Social Security Benefit Scheme was introduced as a preplan for the "Surekuma" pension and security benefit schemes for the children who are below the age of 18 years.

Benefits of the pension scheme

- A provide a pension at theage of 60 years until the demise of the contributory members.
- At the demise of the contributory member before reaching to the age of 80 years
 - 1. If the spouse is alive he/she is entitled to the pension up to the age of 80 years

2. If there spouse is no more, his/her nominating successors would be able to obtain the net total contribution and interest deposited on the name of the contributor in return.

- If the contributory member becomes permanent and partially disabled he is entitled to an adjusted gratuity of net contribution according to the insured's age and, after the payment of contribution completely he/she is entitled to the monthly pension after reaching 60 years
- If the contributory member becomes permanent and partially incapacitated he is entitled to an adjusted gratuity according to the insured's age and/or the monthly pension from the date on which the member is incapacitated.

Special financial benefits are granted to the children in the grade five scholarship, General Certificate of Examination (Ordinary Level) and University premises Examination under "Arassawa" social security benefit scheme.

Obtaining the Membership of the Scheme

Any Member of the society could obtain the membership from the Head Office of Sri Lanka Social Security Board, Divisional Secretariats, or through Grama Niladari Officers, Divineguma Development Officers and from any other Officer to whom the responsibility has been entrusted by the Board.

Payment of the Installments

Instalments payment could be made through all Branches of the Bank of Ceylon, Peoples' Bank and National Savings Bank, Post Offices and Grama Niladari Officers to whom the responsibility has been entrusted By the Authority.

The priority need of a Social Security Programme

At present the population of Sri Lanka over 60 years by 2012 was 12.2% and it represented 2,468,329 elders. It is estimated this percentage to be increased up to 24.4% by 2041. Representing a large portion of elders in the will be a threat to senior citizens, children and generally to the all communities.

Having drawn special attention, in this regard, considerable number of social security programmes have been included in the government policies following the identification of the elders as the senior citizens. Sri Lanka Social Security Board is highly committed to fulfill the national responsibility of assuring the pension and social security benefits towards the future senior citizens while making them more secured and dignified community.

In parallel to this, we work together with the National pension services (NPS), which is the state institution in South Korea to implement a social security programme and representatives of the said Institution, have visitedthis Board and had a discussion with the Authority. Moreover, Officers of this Board participated in the Training course on pension of Asia and Pacific zone held in South Korea in 2015 and 2016. The basic foundation has been made to sign the memorandum of understanding (MOU) between two countries on this matter because the service experiences and methodologies of the said institution are very important to this Board.

Actions are in the process of obtaining the service of a foreign consultant under the sponsorship of the National Pension service (NPS) and South Korean Embassy in Colombo in the year 2007.

10.Other Activities

10.1. Special Projects implemented by the Ministry in 2016 and its progress.

Re-formulation of the Family Policy for Sri Lanka

In accordance of with the cabinet decision dated 15.12.2011. It was decided to formulate the family policy again with the board frame work that to be fit for strengthening as the primary unit in the society while empowering the family in economic, social and spiritual means, because the family policy, which was presented in the year 2011 as a draft, was only discussed about the disadvantaged people in the society.

In subsequence, a committee, under the chairmanship of Pro.K. Karunathilaka of University of Kelaniya, has formulated this document with the broader vision. Presently, trilingual translation activities (Sinhala, Tamil, and English) are under the process. In subsequence, English copy should be developed up to the standard and language development activities in the Tamil and Sinhala copies are to be done.

For formulating the family policy Rs.02 Million was estimated. Rs. 1.093 Million has already been spent, provisions were not allocation for this purpose for this year and it has been included in the next year budget estimation for obtaining the required provisions for the future activities.

> Establishment of the National Volunteering Secretariat (NVS).

The National Volunteering Secretariat Sri Lanka was established in 2013 under the Ministry of Social Empowerment & Welfare in collaboration with the Ministry of Finance & Planning, UNDP and UNV. Preliminary Activities in this connections were done by UNDP and the Secretariat was established under the direct financial contribution of the UNDP. A website was launched for two activities of this Secretariat under the sponsorship of UNDP in the year 2014 and National Policy on Volunteerism was drafted.

UNDP project was ended by March 2015 and the National Volunteering Secretariat was handed over to authority of the Ministry by UNV Officers.
